RE: The Draft Heritage Communities Local Area Plan

I write to express <u>my support for the proposed Heritage Communities Local Area Plan</u>, which I believe presents a well-balanced approach to accommodating new homes and businesses in the area. While the creation of the plan is an important step; it is just the beginning of a long process to enhance the area's assets and services. I would like to ask for clarification in the plan on a few key issues regarding the implementation of the plan. For example:

- 1. Which *City Service Lines* (www.calgary.ca/service-lines/2023-2026-city-services.html) will be responsible for helping Councillors and citizens in realizing the over 60 service & public realm improvements listed on pages 101-104 of the plan?
- 2. Why does the plan not reference the Council-approved 2015 Macleod Trail Corridor Study, which proves a 5A network is possible while still maintaining 6 vehicle lanes? www.calgary.ca/planning/transportation/macleod-trail-corridor-study.html. While not ideal for commuter cyclists, (Haddon Rd / 5 St SW is great!) there is definitely opportunity for cycling to/from local destinations on Macleod Trail.
- 3. Where can citizens turn for assistance in developing plans for affordable housing on vacant cityowned lands and refreshing of underutilized parks and open spaces?

Staff from the City Planning & Policy Service line who led the creation of this plan will be needed elsewhere to complete the 39 remaining local area plans. Therefore, realizing public realm and service improvements requires assistance from other City Services lines. *But how do citizens, Councillors and Service Line Owners know who from The City should be involved in various public realm improvements?*

Subsequent to adopting this plan, I would strongly encourage Council and Administration to embrace the model of **Asset Based Community Development** (www.nurturedevelopment.org/asset-based-community-development/) and allow regular community-led updates to sections 3 & 4 of new local area plans. Those two chapters describe the public realm and service improvements needed to support future growth. Citizens and councillors deserve an active voice in planning and realizing the services they want for the area.

Table 1, following this letter, provides an example of how to supplement pages 101-104 of the proposed plan by identifying relevant City Service Lines required to realize the over 60 citizen-generated public realm initiatives listed on pages 101-104. Knowing the relevant Service Line(s) instantly adds a link into the respective capital and operating budgets that could assist with realizing a desired improvement.

In conclusion, I strongly support the approval of the proposed Heritage Communities Local Area Plan. This plan aligns with the trend of having cities where all services are within a 15-minute reach and puts Calgary's Planning and Policy Service Line at the forefront of City Planning in North America.

Further, if Council would embrace the Asset-Based Community Planning Model and allow future community-led updates to Chapters 3 & 4 then I think it will help realize the public realm improvements that matter the most to the residents, businesses, and landowners in the Heritage Communities area.

Thank you for your consideration for integrating City Service Lines, and therefore City Budgeting, directly into new Local Area Plans.

Dear IPC and Council,

Re: Heritage LAP

The Chinook Park, Kelvin Grove, Eagle Ridge (CKE) Community Association commissioned a community wide professional survey to determine what residents felt about the proposed densification of our neighbourhoods. The survey received a statistically valid response rate and concluded that over 80% of responding residents wish to preserve the single-family character of the three neighbourhoods. I am among the 80%. The current draft of the LAP green lights the blanket densification of our three neighbourhoods. Despite repeated requests to revise the LAP to preserve our single-family character, the City Planners have refused. We ask that the Infrastructure and Planning Committee recommend to Council that the LAP be revised to preserve the single-family character of CKE.

The current draft is of enormous concern for me/us and many members in our community.

We purposefully moved away from a densified area in Calgary (3 times) as we wanted to be away from densified crime, densified parking, densified playground, noise, pollution from densified cars, away from so many people on crowded sidewalks. We needed to have a yard, with mature trees (at least one), a safe place for my children's friends to play in an actual yard, a place where we can walk down the sidewalk and have a chance meeting with a neighbor and talk without having to yell over the noise, a place where my children can feel safe just walking outside, riding their bike, and creating lasting positive memories. This builds a strong, resilient, community.

I understand there is a significant climate concern and my family is doing their part to help. But densification by removing nature, crowding people together, increasing noise, decreasing safety, are not in my view, a long-term viable option. This just creates more problems and doesn't address the climate issue. Densification increases heat, increases carbon, increases crime and increases health problems (various studies in Psychology, environmental design, anthropology and climate support this).

I'm Hanita Simard, and I've lived on this planet for about 5 decades, and in Kelvin Grove, the K in CKE, for 2 of those decades.

I am in favour of the LAP for 4 reasons:

1. Increasing Population

When I was born, the world's population was 3.7 billion. Today it is 8 billion.

When CKE was built in the 1950s, the population of Calgary was about 160 000 Today Calgary's population is 1.3 million.

The earth hasn't gotten bigger.

The resources we need to sustain human life are seriously finite.

And weirdly, while the population almost everywhere else on the planet and this city has increased, the population in CKE has not. Average residents per house in Kelvin Grove, my community, has dropped from about 4 when the community was new, to about 2 now. And that is a trend that is expected to continue.

CKE needs to start being a community that is a vibrant and dynamic part of this planet, part of this city. We need to have more neighbors, more community members, more young people, more families, more seniors. We need a community that is more equitable and sustainable. We need to have a community where the schools and services around it are viable, not a community that is aging and in which the population is declining, as it currently is.

2. Climate Crisis

When I was born the ppm of CO2 in the Earth's atmosphere was 326.42. Today it is 416.43 ppm.

To put this into perspective, previous to the 1930s, and for over 800 000 years, the CO2 levels were never above 300 ppm.

To put this into perspective, the IPCC's final report came out on Monday March 20, 2023, and they said we have 7 years to take action, 7 years to decide if we want to ensure that life for humans on this planet is not miserable. The climate crisis is the biggest threat to human life, and so far no one has done enough to address it.

The LAP addresses some of that,

- -by supporting more homes for more people closer to where people work.
- -by ensuring resources are available and accessible in each community
- -by increasing livability, walkability, and rideability throughout our communities, decreasing our reliance on individual vehicles (now we just need better and electric public transportation infrastructure!)

3. Schools in Aging Inner City Communities need a boost or they will be closed

In the 1970s, the schools in CKE were filled to the brim with students who lived in local communities and went to local schools. Today, the schools in our communities struggle to have enough students to pay for maintenance, and sometimes struggle to have enough students enrolled.

I chose to live in CKE for two main reasons. The first because it is on the No.3 bus line, and the second because of the schools. My kids walk to their local neighborhood public schools and it is just the best. However

- as the size of families have decreased and will continue to decrease,
- as the community ages, as property values increase,
- the difficulty for young families to afford homes in CKE,
- as people make choices to send their kids to other schools

we see the impact of this on our local public schools, which are struggling with declining student numbers. The LAP, by increasing housing and business options, making communities more livable, increases the viability of our local public schools, and not only ensures that kids have access to great public education, but that the heart of our community remains strong.

4. Housing Shortage and Affordability Crises

Like many big cities in Canada, we simply don't have enough housing options, especially in the middle range, and we don't have enough homes that people can afford, especially in the inner city. It just doesn't make sense to constantly push people out to the periphery of the city, expanding our city's sprawl, and all the negative stuff that comes with that, when we have the ability to make a real positive change in aging inner city communities. And specifically it doesn't make sense that while the city is absorbing new people and is relatively young, CKE isn't absorbing any new people and is getting older. The LAP revitalizes communities by providing more choice and flexibility for current and future property owners, by bringing more neighbors into communities, by creating more equitable and livable communities.

Conclusion

I want to live in a community that has more neighbors, that has more community.

I want to live in a community where residents who have lived here for decades can continue to live with neighbors and friends because there is suitable and affordable accommodation, and services and shops that are easily accessed.

I want to live in a community that is welcoming to new residents, and that sees new community members as vital to our community's health.

I want young adults to be able to make CKE their home because we have affordable housing for young people establishing their careers, and a vibrant community where they want to hang out in, and great public transportation so they can work and play throughout the city.

I want families to want to live in CKE and be able to do so because of

- the great public schools,
- excellent public transportation,
- access to public health services,
- a choice of housing that works for all life stages and different budgets,
- and businesses that thrive and are sustainable

because we have diverse, equitable, liveable, and healthy communities.

I want to live in a community that continues to grow, respond to and change with the needs of citizens, the community, the city, and the planet.

I want all of this in addition to what we already have, and the LAP helps to makes this possible.

This document should not be approved by the committee until it actually takes into consideration community input. Otherwise, the so called engagement process continues to be truly a sham as it was for the BRT project.

The letter is written on behalf of the Haysboro Community Association to express support for the final draft of the Heritage Communities Local Area Plan that city administration will be presenting to the Infrastructure & Planning Committee on April 5, 2023.

We are pleased to see the establishment of a long-term plan for the evolution of Haysboro and surrounding communities. Our community is an older community, established in the late 1950s that has been home to multiple generations of families. Its appeal was, and is, wide-ranging. It offers a close-knit community with unparalleled access to places of employment including Calgary's Downtown Core; natural spaces such as those surrounding the Glenmore Reservoir; commercial services and recreational facilities along McLeod Trail; and health services through Rockyview General Hospital. It is a community that serves its population well and has great potential to continue to do so in the future.

We understand that Calgary's established neighbourhoods have experienced a decline in population over past decades and Haysboro is no exception. This unfortunate decline is best demonstrated by the utilization rates of the schools in the community. Some are now low enough that the threat of permanent closure looms. School closure is particularly distressing because their purpose is to usher in the new generation. Low utilization is an obvious sign that new families are needed in the community. New families are necessary for the longevity of the community.

The Heritage Communities Local Area Plan sets the foundation for growth by accommodating evolved living requirements for families. It anticipates emerging trends and provides opportunities such as multi-generational living arrangements, child-care centers, and senior living. At the same time, it protects the residential character of the community, by maintaining current building types and form through much of the community.

We'd like to draw attention to implementation options identified in Section 3.2 that have been developed by city administration based on feedback from the community. We support these projects and encourage council to prioritize these for future investment, recognizing a need for life-cycle improvements to existing infrastructure, that will improve mobility and connectivity, transit stations, and parks spaces. We believe these investments are necessary to attract new families and investment in the community.

The plan suggests development of Transit Station Area Public Space Plans that will consider improvements for the public realm and mobility connections to transit stations. We support this as it would work to address uncertainty surrounding the Heritage LRT station as well as the city-owned lot across Haddon Road that was the site of the former YMCA facility.

We support the inclusion of the 5 Street SW / Haddon Road SW / Sacramento Road SW Greenway, recognizing this route as an important north-south mobility connection linking Kingsland, Haysboro, and Southwood and believe this to be a viable candidate for investment. We, similarly, support inclusion of the 89 Avenue SW Greenway that could be formalized as an important east-west connection between Glenmore Landing and 14th Street SW and Haddon Road SW.

Finally, we support inclusion of the MacLeod Trail SE Urban Main Street Area and advocate for its funding and advancement within the Main Streets program.

Re: Heritage LAP

Upon review of the Heritage LAP coming to committee April 5th, 2023; the Acadia Community Association would like to bring forward some concerns.

The first concern is with the general wording within the LAP.

Most of the language within is very non-committal - such as the use of words like 'should', 'might', and 'if'. Considering the amount of work that has gone into the plan, the use of non-committal language in the LAP could easily be interpreted to align with just about any application regardless of if it aligns with the spirit of the LAP. It is suggested the MDP would trump any firmer wording the LAP might have, it is therefore the position of the Acadia Community Association that the Heritage LAP needs to have wording to support a succinct interpretation of the MDP that will give the plan the tooth the communities involved need.

Secondly, the protection of green spaces.

In the community of Acadia the majority of green space is school board 'asset'. Acadia has less than the norm of Municipal Reserve.

We continually struggle when we hear that school boards are permitted to sell off public asset to their benefit. As this seems to be a trend, it is not difficult to think that Acadia could embrace an appropriate densification plan only to have the attractiveness of great local green space be taken away.

As this particular interaction is likely not exactly within the scope of the LAP, we hope some conversation is occurring to retain green space as density increases.

On a positive note.

When this LAP began, it was confirmed that the plan would not purposefully be including the applicable mobility-related City documentation.

It is difficult (if not impossible) to create a fulsome plan for livable spaces if how we get around is not included. We are very pleased to hear the city is embracing a multidisciplinary approach to our spaces (especially to spaces that have a considerable people element), to ensure mobility options will be available and inclusive, and that livability isn't being diminished due to poor (notably road) design choices.

Our community is within the proposed Heritage Local Area plan, specifically, the CKE neighbourhood of Kelvin Grove. The plan will allow for a level of densification which is not in keeping with our neighbourhood by design or infrastructure. The desired densification targets within our area have already been achieved, most notably by the the Mayfair towers and other multi residential properties and retail along Elbow Drive. There are other areas with an obvious NEED for densification and an overall area improvement - like along McLeod trail. The area is under utilized and lacks any sort of functionality or appeal. City focus should be put in these areas of need first. There is also the proposed "midtown station" development at Glenmore and McLeod Trail, which will provide densification of a SIGNIFICANT nature. The project and its size is something unique to our neighbourhood and I do not believe exist anywhere else within the City. The project may change, but the potential for future densification is there and will happen to some degree.

These are only a few ways our community either HAVE, NEED or COULD receive the densification detailed in the plan, without going into the existing residential areas in the community.

Most residents have purchased their homes with the desire to live in a single family community, not next to multi residential/retail developments and be impacted by the changes that come with them (parking, traffic, overcrowding of schools, lack of proper maintenance, but more so the lost appeal of the original design to the community). Failure to recognize these as genuine and real concerns is simply irresponsible. We hope the City will do the right thing by focusing on where the true needs of the community are. Listen to the overwhelming response of the residents in our communities who know them best, and strongly oppose the plan extending into their neighbour-
