## **Distribution of Grant Funding**

Throughout 2021, Council directed Administration to develop relief options to support local businesses. Relief options included:

- waiving up to \$17.6 million in business licence fees between March 17, 2021 March 16, 2023.
- tax deferral for hotel/motel non-residential property owners,
- Calgary Reopening Grant for Restaurants, Pubs and Bars,
- Calgary Reopening Grant for Fitness Facilities,
- Calgary Reopening Grant for Entertainment Establishments
- Calgary COVID-19 Business Support Program.

The Reopening Grants that were established and operated as follows:

- Restaurants, pubs, bars could receive a grant of \$2,500 per physical permanent premise up to a
  maximum of three locations. A maximum of \$9.5 million in funds were made available to this
  group. (RELIEF-RES)
- Fitness centres (including fitness studios) could receive a grant of up to \$7,500 per physical permanent premise up to a maximum of three locations and a maximum of \$3 million was made available to this category. (RELIEF-FIT)
- Entertainment establishments (night clubs and music venues only) that were fully closed since
  the beginning of the pandemic were eligible to receive a grant of \$15,000 per physical
  permanent premises up to a maximum of three locations. \$500,000 was available for businesses
  in this category. (RELIEF-ENT)

The program accepted applications between July 2 – August 10, 2021.

In September 2021, the three Reopening Grant programs were merged into The Calgary COVID-19 Business Support Program. This program was used to fund the Restrictions Exemption Program Business Support Grant (RELIEF-REP). The REP Business Grant provided grants of \$2,500 to those businesses who were obligated to follow the Restrictions Exemption Program as per City of Calgary Bylaw 65M2021.

As of July 12, 2022, the distribution to businesses through all of these grant programs was as follows:
