

Did you know...

- ✓ The City of Calgary is already planning on building 16 **low-income rental apartments** on 8 lots in the Rosedale Neighbourhood?
 - On very small lots designated as “**remnant parcels**”
- ✓ The City sub-divided the old lots and **rezoned them for multiple dwellings**?
 - Rezoned to RC1-5 to allow for **secondary suites**.
- ✓ City Council will vote to **approve** this project in September?
- ✓ The City plans on building two-story low-income apartments that are 14 feet wide by 40 feet long (14' x 40' = 560 sq/ft) and states they will fit into the **architectural style** of our neighbourhood?
- ✓ The City has been holding **individual street meetings** with only small groups of people being invited?
 - Not the whole community: Is this a **Divide and Conquer** strategy?
- ✓ The City has **refused** to sell these lots to people who live in our neighbourhood?
