## Blakiston Park Engagement and Detailed Design Application

Patrick Wiley and Keath Parker provided a short presentation on the project, timelines, and phasing, and requested support an additional allocation in the amount of \$350K to be earmarked for engagement and detailed design. The RFP consultant has been selected, and procurement is awaiting council approval of the funds before the contract can begin.

Recommend to Council the authorization of an expenditure of up to \$375,000 from the BCEF for the purpose of conceptual design, public engagement and detailed design for Blakiston Park improvements. (Moved by Joe Starkman. Unanimous approval)

Further, authorize the BCEF Administrative Committee, to approve the expenditure of further funds from the BCEF for the purpose of park construction up to a total of \$575,000 without further Council approval. (Moved by Cheri Macaulay. Unanimous approval)

#### **Discussion**

There is potential for additional costs to the City in delaying design solutions with respect to the interface between the final phases of University City and the grade change along Blakiston Park. The design and construction of the interface will need to be resolved prior to October 2015 in order to avoid the construction of a retaining wall.

Engagement with the community is highly desired before summer. July and August are typically the worst months during which to get input from local residents. Targeted engagement at an early stage to resolve the interface between the park and university city buildings is desirable.

Complete construction costs may be covered by CRIPS in future. Timeline is unknown. The first phase of construction should occur as soon as possible after the design and engagement are completed. A second motion to allow expenditure on construction of up to \$575K would help.

Council target is June 9 2014.
