Background and Previous Council Direction

This attachment provides background and previous Council direction related to new community growth decisions, and a status update on Administration's progress in meeting the directions.

Background

In 2020, Council directed Administration to rethink the Growth Management Overlay system. The Previous Council Direction in this attachment focuses on the most applicable direction to Administration in that regard and Administration's response to date.

In previous reports (PFC2021-0649, Attachment 1) the full history of the Growth Management Overlay and new community business case evaluation system was outlined. The Growth Management Overlay was introduced in response to a significant increase in the planned land supply (i.e. lands with approved Area Structure Plans) with the introduction of developer funded Area Structure Plans. A tool was needed to signal which areas were, and were not, funded for required servicing. Under this system, the Growth Management Overlay was the "signal" within the Area Structure Plans. The biannual business case evaluation system was introduced as the process by which an applicant could seek removal of the Growth Management Overlay by asking that necessary City investments be funded through Service Plans and Budgets.

The business case system has most recently been used in 2018, 2020 and 2022 to deliver investment recommendations on new community growth to Council.
