Dear Members of Council,

As an organization committed to serving and advocating for women in our community who are vulnerable, the YWCA of Calgary supports the development of a comprehensive, community affordable housing strategy.

The YWCA provides a variety of emergency shelter and housing services for women experiencing family violence, homelessness, isolation and poverty. In 2013, 1,224 women and 328 children spent at least one night under a YWCA of Calgary roof.

The length of time women stayed in the YWCA Sheriff King Home emergency shelter and the YWCA Mary Dover House supportive housing program in 2013 increased significantly over prior years due, primarily, to their inability to secure other accommodations. Daily, we support women to find safe, affordable and appropriate housing in Calgary's ever-tightening rental market.

We know that the availability of housing for people at all income levels will be essential to the YWCA achieving its vision of "women thriving in a safe and equitable community." We cannot achieve this alone and hope Council supports this strategy development request.

Just as we supported the development of the laudable Calgary Poverty Reduction Strategy, we look forward to working alongside elected officials, City administration, non-profit and industry partners in the articulation and realization of a housing continuum to meet the needs of all Calgarians. We are grateful for continued funding support from the City of Calgary – Family and Community Support Services which helps to enable our services.

As Calgary experiences constricted vacancy rates and rents increase to record highs, it is more important than ever to ensure affordable housing options exist within our city.

As a leader in the affordable housing sector, Horizon Housing Society fully supports the development of a comprehensive affordable housing strategy.

Horizon Housing Society has been providing affordable, integrated and supported homes for people in need. The Society currently owns and operates 581 units of affordable housing in Calgary. Our properties range from individual group homes to multi-family apartment properties. We span a variety of locations throughout the city and promote a mixed-use concept for our residences. We serve tenants with a variety of special needs including mental health challenges, physical disability, families and seniors living below the poverty line and the working poor. This type of housing helps reduce the stigma attached to a particular group and promotes community integration, independent living and acceptance while enhancing our tenants' quality of life.
