

Ward Community Event Financial Summary, 2023 April

The eleven (11) applications requesting approval total \$ 7,093.98, leaving \$112,514.02 available for granting in 2023.

During its 2017 January 26 meeting, it was clarified that any returned grant funds would be applied to the Ward office for use during the current grant year.

² During its 2017 March 23 meeting, WCEF Guidelines were amended for section 10.a) Year-end Surplus to indicate that any WCEF grant funds not previously awarded in a calendar year shall be returned to the City of Calgary.

³ The Annual Amount Available will be a combination of the equal distribution of WCEF annual grant funds available among the 14 Ward offices plus any Returned Funds Received within a calendar year.
