NOTE:

Second and third readings were withheld on 2023 January 17 pending review of the Westbrook Communities Local Area Plan for alignment with the Growth Plan by the Calgary Metropolitan Region Board (CMRB). This tabulation is to advise that the CMRB has reviewed and approved the proposed Westbrook Communities Local Area Plan against the Regional Evaluation Framework. The CMRB deemed the proposed Westbrook Communities Local Area Plan to be consistent with the objectives of the Calgary Metropolitan Regional Growth Plan and recommended approval on 2023 March 16. Thus, the bylaws for the Westbrook Communities Local Area Plan

and the amendments to the Richmond Area

Redevelopment Plan may return to Council for second and

third readings.
