

# Background and Previous Council Direction

## Background

---

The Business Advisory Committee (BAC) had its first meeting in April 2019. Since that time, meetings have been conducted with the BAC and a Working Group, comprised of representatives from a cross-section of business sectors. In 2022, one of the priorities of the BAC was to reduce red tape, which was further refined to a priority of Streamlining the Change of Use process, Priority 2B (BAC2022-0518).

On 2022 October 11, the Business and Local Economy Team presented an update report (BAC2022-1129) to the BAC and was approved by Council on 2022 November 1. In this report, Administration was directed to scope work on how to Streamline the Change of Use process and update BAC on the scoping work, no later than the end of Q1 2023.

In Q4 2022, Planning and Development Services initiated additional work in finding opportunities to streamline the Change of Use process. Improvements to safety code permits and inspections, as well as business licencing, has been done or is ongoing. The focus of this report is improving the development permit process through regulation changes to the Land Use Bylaw (LUB).

In Q2 2023, Planning and Development Services presented results from a scoping exercise and presented four changes to the Land Use Bylaw to Streamline the Change of Use process for the BAC's consideration (BAC2023-0351).
