

**BYLAW NUMBER 19M2014**

**BEING A BYLAW OF THE CITY OF CALGARY  
AUTHORIZING THE IMPOSITION OF A 2014  
BOULEVARD TAX FOR THE COMMUNITY  
OF HAWKWOOD**

\*\*\*\*\*

**WHEREAS** the residents of a community within the City of Calgary known as Hawkwood have requested that a special tax be imposed on homeowners in this community to raise funds to provide for the maintenance of the boulevards and common areas;

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**

1. This Bylaw may be cited as the "2014 Hawkwood Boulevard Tax Bylaw".
2. This Bylaw is enacted for the sole purpose of raising revenue to provide for the costs of and ancillary to the maintenance of boulevards and common areas located within the community of Hawkwood and estimated to be \$185,377.95.
3. The ancillary costs referred to in paragraph 2 must not exceed \$2,000.00.
4. The area of the municipality to benefit from this Bylaw is the community of Hawkwood as identified in the map attached as Schedule "1".
5. A tax for the year 2014 of \$58.35 per parcel of land shall be imposed on each parcel of residential land benefiting from this Bylaw.
6. The use of the funds described in paragraph 2 shall be contingent on the community of Hawkwood entering into any agreements with The City of Calgary that are necessary to carry out The City of Calgary's auditing requirements and procedures.

7. This Bylaw comes into force on the date it is passed.
