



- 2. Address legislative barriers impacting The City's ability to address problem properties.





Strategic Oversight Committee



Provides strategic direction and outward communication and reporting.

Operational Oversight & Support Hub

Inspector

Communicates upward and outward to the situation response team partners. Provides operational oversight of situation response teams to ensure that partner relationships are maintained and manages any property cross-over situations. Provides oversight for support hub roles.

Data

Develops risk models, provides trend analysis, and reports performance metrics.

Provides legal advice and support for complex situations.

Communications

Develops and oversees the communication strategy.

Situation Response Teams ြိုင်္သြာ



Each situation response team member brings a specialty to the table in five focus areas. Front-line professionals come together regularly to address complex property situations in a collaborative setting. The teams use risk modelling to determine a problem property status and work together to determine which agencies need to be involved, how to leverage authorities, partnerships, and other resources to elevate their response. A lead organization is assigned to ensure the work is carried out.




Some partners may not be involved on the situation response teams at all times but could be called in to support as required. The resource bank also houses quick reference guides.
