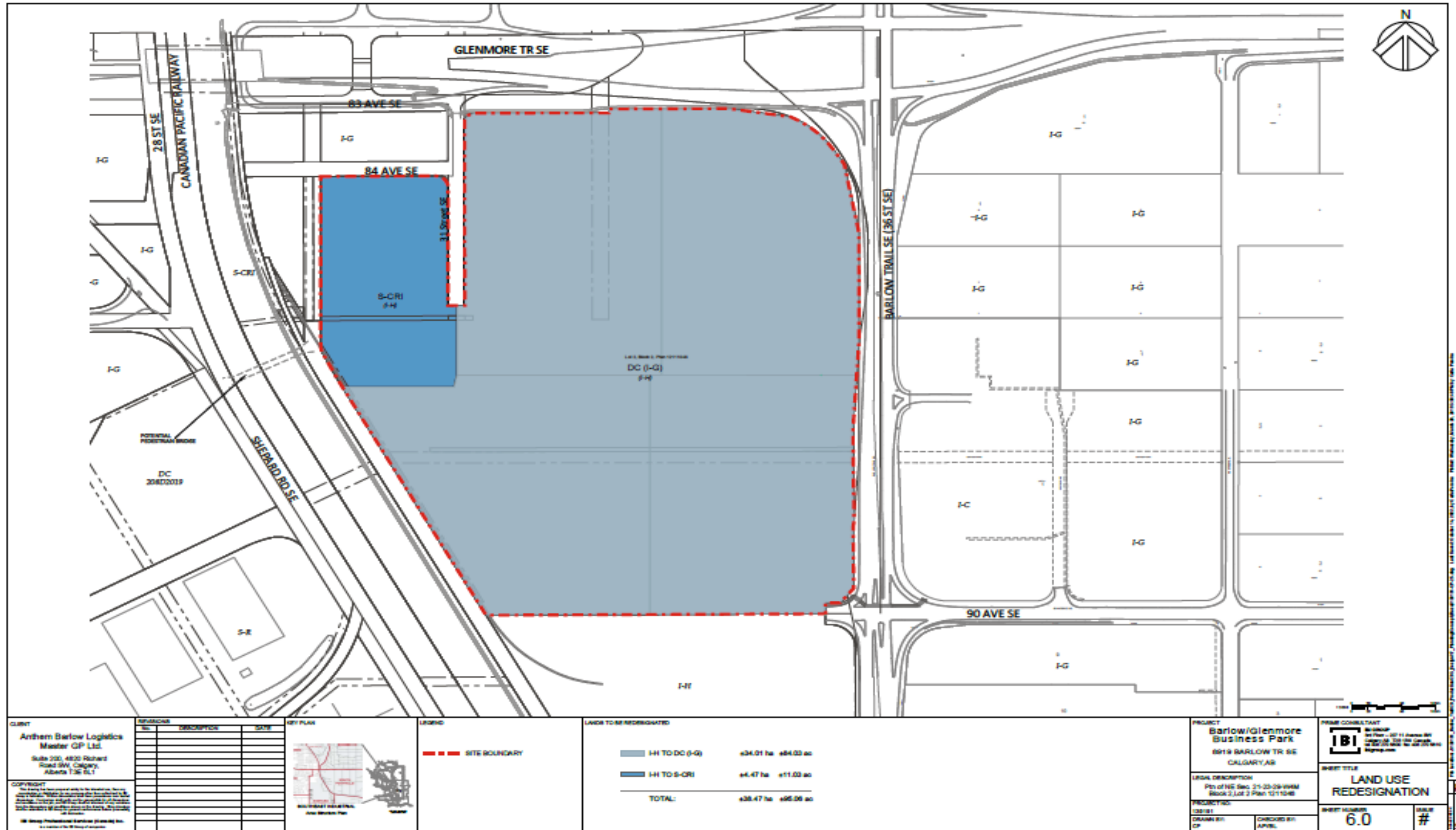


Proposed Land Use District Map
