If the infrastructure projects listed below are not funded or constructed, the transportation components of a Growth Application process may be deemed to be satisfied if a TIA indicates, to the satisfaction of The City, that a proposal is in place to mitigate negative impacts.

- (d) Remove Section 8.3 entitled "Growth Management" from the Table of Contents, and renumber subsequent sections under Section 8.0 "Implementation".
- (e) Remove Map 7 entitled "Growth Management Overlay" from the Table of Contents under "Maps".

In the case that the infrastructure components listed below are not funded or in place, the transportation infrastructure components of a growth management overlay removal process may be deemed to be satisfied if alternatives are determined that are to the satisfaction of the City through the completion of a TIA.
- (d) Remove Section 7.2 entitled "Growth Management" from the Table of Contents, and renumber subsequent sections under Section 7.0 "Implementation".
- (e) Remove Map 10 entitled "Growth Management Overlay" from the Table of Contents under "Maps".
