I am writing as a resident of University Heights, expressing deep concern over the proposed land development project which primarily includes medical-use spaces. While I appreciate the importance of healthcare facilities, I believe a balance of amenities is vital to foster a vibrant, walkable community.

This neighborhood, conveniently located close to the University of Calgary, is home to many students, among others, who do not have access to personal transportation. The planned predominance of medical-use spaces may potentially neglect their practical needs and the essence of a lively, pedestrian-friendly environment.

I am very disappointed to learn the CPC is considering a change to the ARP to this development. The previously approved documents approved development of 11,148m2 for Health Care Service however there is a current request to adding up to 31,148m2. This is a huge increase in square footage for the scope of development and I have serious concerns about increased traffic in an already potentially busy area. Two years ago, the rep for Uxborough claimed previously performed traffic studies showed there would be no effect on traffic flow to the neighborhood of University Ht and UofC using the current traffic circle and single entrance/exit from the new development. That comment seemed preposterous at the time and will surely be significantly affected by expanding area development. What was previously a retail strip mall heavily supported by the local community, will be turning into another site for a medical center. How can traffic not be effected? Traffic through University Hts already comes to a stand still daily during student pick up and drop off at Westmont school. Unwin rd is is not built to support the kind of traffic we will be seeing.

Is additional parking proposed to accommodate the patients & staff who will be utilizing these facilities? Staff may take public transport, but patients and caregivers will not. Where will they park?

Densification of this corner is becoming overwhelming. Seems like the city has no respect for the surrounding communities and concerns about traffic and noise. As it is, we live by a major medical center and hear helicopters overhead multiple times a day bringing patients to CHA & the Foothills as well as constant ambulances. That cannot be helped...Foothills has been here for years and we appreciate the quality healthcare provided. But it isn't necessary to expand services at this location even more when other land is available for nearby development which will spread the traffic and noise
