

Highlights (Slide 2 of 2)

- This report:
 - complies with the Ward Boundary
 Determination and Review Policy to
 review of the city's population deviation in
 each ward to determine if ward boundary
 changes are required for the 2025
 General Election; and
 - in keeping with the Policy, no changes to ward boundaries are required for the 2025 General Election.
- What does this mean to Calgarians? Should Council direct a Ward Boundary Commission, Calgarians will have the opportunity to provide input on effective representation.
- Why does this matter? Regular review of Council's composition and alignment with the Policy requirement help to facilitate effective representation for Calgarians.

Ward Boundary Commission

- Independent and impartial
- 5 voting members:
 - One person who understands The City from a political and organizational perspective, such as a former member of Council who has not sought election in the most recent election;
 - Two electors with an interest and expertise in political science, public policy, or urban issues; and
 - Two residents of Calgary.
- Includes the Returning Officer or delegate (non-voting member).
- Will conduct internal and public engagement.
- Will report back to Council with two reports:
 - 1. Engagement plan: public and interested parties.
 - 2. Recommendations: Council composition and effectiveness.


Council

- Directs forming a Ward Boundary Commission.
- Approves Ward Boundary Commission engagement plan.
- Considers the Ward Boundary Commission's recommendations related to Council composition, effectiveness measures and changes to the Ward Boundary Determination and Review Policy.
- Directs Council composition and effectiveness measures.
- Approves amendments to Ward Boundary Determination and Review Policy.
