What is the need?



Over 80,000

Calgary households cannot afford their housing.



1 in 10

Calgary households are at risk of experiencing homelessness.

Calgary has a serious **affordable housing supply deficit** & is at risk of experiencing of an overall **housing supply deficit**.

What do Calgarians think?

72% want more investment in Affordable Housing. It is the highest ranked service.

94% see Affordable Housing as somewhat or **very important**.

Affordable Housing was a **top election priority** for Calgarians.


