DISCUSSION

This application in the southeast community of Residual Sub-Area 12I was submitted by B&A Planning Group on behalf of the developers, Genesis Land Development Corp., Brookfield Residential and Telsec. The subject land is located north of the Bow River, east of Deerfoot Trail, south of 112 Avenue SE and west of 88 Street SE. Location Maps are provided in Attachment 1.

A concurrent land use amendment and outline plan application (LOC2020-0100, Attachment 2) has been submitted and is on today's agenda (CPC2023-0295).

Ricardo Ranch is proposed as the community name in recognition of the 1,355 hectare (3,348 acre) working cattle ranch, Ricardo Ranch, part of which occupies the subject lands. Ricardo Ranch also matches the name of the approved Area Structure Plan. The Plan area, approximately 635 hectares, falls within the boundaries of Ricardo Ranch, the name which has endured for 130 years, even as the land changed hands from William Crawly Ricardo to Senator Patrick Burns, and ultimately to the Soutzo Family.

Ricardo Ranch is also being proposed as a street name. This is complimented by recognizing the natural elements of the land by using the names of Flora and Fauna found in the Alberta Grasslands for additional street names.

These are Badger, Bobcat, Buffaloberry, Bull Trout. Cattail, Coyote, Chokecherry, Grizzly, Jack Rabbit, June Grass, Mink, Mule Deer, Muskrat, Nuttall, Oat Grass, Painted Turtle, Porcupine, Prairie Dog, Prairie Smoke, Pronghorn, Rainbow Trout, River Otter, Snowberry, Spear Grass, Stickleback, Walleye, Wheat Grass, Whitetail, Wild Rose and Wolverine.
