#### BACKGROUND

The Calgary Public Library Board has full management and control of the Calgary Public Library and in accordance with the regulations, organizes, promotes and maintains comprehensive and efficient library services in the City of Calgary and may cooperate with other boards and libraries in the provision of those services.

With respect to appointments, Section 4 of the *Libraries Act* states that a municipal board shall consist of not fewer than 5 and not more than 10 members appointed by council, a person who is an employee of the municipal board is not eligible to be a member of that board, and not more than 2 members of council may be members of the municipal board.

According to Section 5 of the <u>Calgary Public Library Board Bylaw</u>, 38M2006, the Calgary Public Library Board shall consist of ten (10) members appointed by Council, no more than two (2) members of Council may be appointed at any one time, and no person shall be appointed as a member who is an employee of the Calgary Public Library Board. The Calgary Public Library Board's current member composition is detailed in Attachment 1.

Following the resignation, there will be seven (7) Elector members remaining. The quorum for any meeting of the Calgary Rublic Library Board is six (6) members. The Calgary Public Library Board meets on the last Wednesday of the each month. The next meeting is scheduled to be held on 2014 February 26.

# INVESTIGATION: ALTERNATIVES AND ANALYSIS

On 2014 January 17, the City Clerk's Office received notification from the Calgary Public Library Board advising that Ms. Lorraine Chan resigned from her position on 2013 October 23 (Attachment 2).

On 2014 January 17, the Calgary Public Library Board presented the City Clerk's Office with a nomination to fill the vacancy resulting from the resignation of Ms. Lorraine Chan. The nomination is detailed in Attachment 3. Attached, for Council's review, is a copy of the confidential resume of the Calgary Public Library Board's nominee that was received for consideration during the Calgary Public Library Board's 2013 public advertisement campaign to recruit for vacancies (Attachment 4).

# Stakeholder Engagement, Research and Communication

The Calgary Public Library Board conducted a public advertisement campaign to recruit for Board vacancies in 2013 July/August.
