1. Introduction

The application for which this public hearing was called concerns the proposed community of Logan Landing, which is to be developed by Genesis Land Development.¹ This application proposes to turn approximately 146 hectares of land within the *Ricardo Ranch Area Structure Plan* (“RRASP”) boundaries into 1,587 low-density dwelling units, 369 multi-residential dwelling units, one hectare of commercial units, and seventy hectares of public space, comprising one school, various parks, stormwater infrastructure, and natural areas.² The application also includes provisions for the location and size of future public roads, pathways, utilities, and services.³

The RRASP clearly states that it makes no representations as to the suitability of the region for the uses proposed in the plan.⁴ Instead, “[s]ite conditions or constraints, including environmental constraints, must be assessed on a case-by-case basis during the Outline Plan, *Land Use Amendment*, Subdivision or Development permit application stage.”⁵ The purpose of this submission is to draw Council’s attention to significant constraints that must be assessed when deciding whether to approve the above-mentioned land use amendment application. In particular, this submission will raise potential conflicts between Application LOC2020-0100 and species at risk legislation, both federal and provincial, and federal impact assessment legislation. Based on these identified inconsistencies, we encourage Council to refuse Application LOC2020-0100. In the alternative, we urge Council to table the decision until the following has occurred:

- (1) Genesis Land Development revises its initial plan to include a minimum, 1000-metre setback between the Logan Landing community and the Great Blue Heron rookery; and
- (2) experts conduct studies of the Bank Swallows and their habitat within the RRASP boundaries and, if necessary, Genesis Land Development applies for a *Species at Risk Act* permit to affect the residences of these birds.

2. Genesis Land Development’s Proposed Heron Setback Could Contravene the Alberta Wildlife Act

There is a Great Blue Heron (*Ardea herodias*) nesting colony listed among the “Environmentally Significant Areas” within the RRASP boundaries.⁶ In Alberta, the Ministry of Environment and Parks lists the Great Blue Heron’s conservation status as “sensitive.”⁷ One of the

biggest threats facing Great Blue Herons is disturbance of nests by eagles and humans.⁸ A 2008 study of waterbirds in northeastern Alberta found that the Great Blue Heron was among the species the most sensitive to anthropogenic habitat disturbance.⁹ Another study found that while Great Blue Herons can habituate to low-level human disturbance—the approach of a human pedestrian—in a nesting area, the risk of colony abandonment is highest if the disturbance occurs early in the nesting period.¹⁰ Moreover, as this study considered only a specific low-level human disturbance, the results “cannot be used to predict heron response to larger disturbances, associated with human activity (groups of people, pets, loud voices, machinery, etc.).”¹¹

Genesis Land Development recently announced its plans to protect the Great Blue Heron colony.¹² The developer intends to include an 800-metre setback separating the colony from the development.¹³ Other proposed mitigation measures include the construction of a fence around the rookery with signage to warn people to keep out, as well as a five-year monitoring program.¹⁴

In 2011, the Fish and Wildlife Division of Alberta Sustainable Resources Development issued setback distance guidelines for land use activities in Alberta’s Grassland and Parkland natural regions, in which Calgary is situated.¹⁵ The guidelines state that the recommended setback distances “are based on what experts believe are the thresholds at which human disturbance is likely to cause degradation and possible abandonment of key wildlife areas/sites.”¹⁶ The guidelines also categorize human activities into low-, medium-, and high-impact disturbances.¹⁷ High-impact disturbances include permanent modifications of habitat with a duration that exceeds ten years, such as the construction of buildings and roads.¹⁸

The guidelines recommend a year-round, 1000-metre setback from Great Blue Heron nesting sites for all high-impact disturbances.¹⁹ The proposed Logan Landing community falls into the high-impact category. Thus, Genesis Land Development’s 800-metre setback falls short of the distance recommended by the Province of Alberta.

The discrepancy between the recommended setback and that being proposed by the developer may contravene Alberta’s *Wildlife Act*.²⁰ Section 36(1) states that a person “shall not wilfully molest, *disturb* or destroy a house, nest or den of prescribed wildlife or a beaver dam in

prescribed areas and at prescribed times.”²¹ Section 96 of the *Wildlife Regulation* clarifies that this provision of the *Wildlife Act* applies year-round, across Alberta, to the nests of migratory nongame birds, as defined in the *Migratory Birds Convention Act, 1994*.²² The *Migratory Birds Convention Act, 1994* defines “migratory bird” as a migratory bird referred to in the Convention.²³ The Convention states that migratory birds include migratory nongame birds, such as herons.²⁴ Thus, the prohibition in section 36(1) of the *Wildlife Act* applies to the nests of Great Blue Herons.

The only case that mentions this provision is an application seeking leave to appeal Alberta Energy Resources Conservation Board (“ERCB”) Decision 2011 ABERCB 007.²⁵ The applicant sought leave to appeal the decision on several grounds, one of which was the ERCB’s approval of an exploratory well within 1000 metres of a grizzly bear den without determining whether it breached section 36 of the *Wildlife Act*.²⁶ Because the applicant had missed the deadline for filing an expert report attesting to the presence of the grizzly bear den, the ERCB ruled that the applicant’s testimony regarding the den’s existence was inadmissible.²⁷ At the hearing, the ERCB found there was insufficient evidence to conclude the exploratory well would molest, disturb or destroy the grizzly bear den.²⁸ The ERCB also considered evidence as to the extensive nature of grizzly bear foraging habitat.²⁹ Based on this, the ERCB concluded that “loss of the grizzly bear habitat due to the exploratory well would not be significant.”³⁰ The Court of Appeal held that the ERCB committed no error of law or jurisdiction in arriving at this conclusion and, ultimately, denied the application for leave to appeal.³¹

As this case centers on the reasonableness of the ERCB’s decision-making and does not interpret section 36 of the *Wildlife Act*, it does not create a binding precedent for how to interpret this provision. However, we submit that this case provides insight into the situation at hand. Firstly, the ERCB found that grizzly bear foraging habitat in the area was extensive. Great Blue Heron habitat, however, is much more limited. According to the Alberta Biodiversity Monitoring Institute and Boreal Avian Modelling Project, Great Blue Herons have been detected on only ten sites out of the 1,116 sites sampled across Alberta between 2003 and 2019.³² Secondly, the construction and operation of an exploratory well likely imposes less of a human presence on an area than does the permanent settlement of between 16,000 and 20,000 people, as envisioned in the *RRASP*.³³

In deciding whether to approve the land use redesignation application, we submit that Council should evaluate the extent to which the initial development plans are informed by scientific evidence and conform to provincial wildlife laws. While the jurisprudence is lacking, a court could find that Genesis Land Development’s decision not to implement the recommended

1000-metre setback constitutes a disturbance of the Great Blue Heron's nesting site in contravention of section 36(1) of the *Wildlife Act*. If so, a decision by Council to approve any development plan that does not include a minimum 1000-metre setback would conflict with the City's promise that "where land development is proposed, all applicable Provincial and Municipal regulations must be adhered to or exceeded when it comes to environmental protection."³⁴

3. Ricardo Ranch Development Raises Bank Swallow and *Species at Risk Act* Considerations

In August 2022, Nathaniel Schmidt, an Alberta Wilderness Association board member, found evidence of Bank Swallow burrows within the *RRASP* area.³⁵ The federal *Species at Risk Act* ("SARA" or "Act") protects Bank Swallows (*Riparia riparia*) and their residences.³⁶ The Bank Swallow is a threatened species listed in Part 3 of Schedule 1 of the Act.³⁷

The *RRASP* mentions the Bank Swallow a total of four times.³⁸ While they are described as a "key biophysical feature," the plan fails to mention their status as a threatened species under SARA. The Bank Swallow is a small songbird with brown upperparts, white underparts, and a dark breast band.³⁹ It is known for flying quickly and erratically and has a "buzzy, chattering vocalization."⁴⁰ This species is a highly social bird and makes burrows in eroding vertical banks. It breeds in every province, and summers in South America.⁴¹ Unfortunately, from 1970 to 2011, the Bank Swallow's population decreased by approximately 98%.⁴² It was designated as a threatened species in 2013.⁴³ Recent studies are more hopeful, with one showing a 14% increase in Bank Swallow populations from 2009 to 2019.⁴⁴

3.1 What is SARA?

SARA is a federal statute designed to ensure the protection and conservation of biological diversity in Canada.⁴⁵ The Act has three enumerated purposes: to prevent the extirpation of wildlife, to ensure the recovery of wildlife that are endangered, and to manage wildlife of special concern to prevent extirpation.⁴⁶ It prohibits the killing, harming, or harassing of a threatened species, as well as damaging or destroying the residence of a threatened species.⁴⁷ *SARA* also protects the critical habitat of a threatened species; however, neither the Ricardo Ranch area, nor any nearby regions, are listed as critical habitats.⁴⁸

Importantly, *SARA* applies to the Ricardo Ranch area. Although not every species is automatically protected on private or provincial lands, since the Bank Swallow is a migratory bird protected by the *Migratory Birds Convention Act, 1994*, they are protected wherever they are found.⁴⁹

The competent minister, in this case the Minister of Environment and Climate Change (“Minister”), may enter into agreements with individuals to allow them to engage in an activity that may affect a wildlife species or its residence.⁵⁰ There are several conditions that must be satisfied first:

(2) The agreement may be entered into, or the permit issued, only if the competent minister is of the opinion that

(a) the activity is scientific research relating to the conservation of the species and conducted by qualified persons;

(b) the activity benefits the species or is required to enhance its chance of survival in the wild; or

(c) *affecting the species is incidental to the carrying out of the activity.*

(3) The agreement may be entered into, or the permit issued, only if the competent minister is of the opinion that

(a) all reasonable alternatives to the activity that would reduce the impact on the species have been considered and the best solution has been adopted;

(b) all feasible measures will be taken to minimize the impact of the activity on the species or its critical habitat or the residences of its individuals; and

(c) the activity will not jeopardize the survival or recovery of the species.⁵¹

3.2 Application to the Ricardo Ranch Area

According to the *RRASP* and Schmidt’s photographic evidence, Bank Swallows reside and nest in the Ricardo Ranch area.⁵² It is highly likely that alterations to this area will result in damage to or destruction of Bank Swallow residences. Damage to or destruction of Bank Swallow habitat is a *prima facie* violation of *SARA*.⁵³ Currently, the only note in the *RRASP* regarding Bank Swallows is that their preservation is a “priority.”⁵⁴ In one report, the developer promises not to develop within sixty meters of Bank Swallows’ nests.⁵⁵ This means the developer would likely need to apply for a permit to continue its development activities. As of April 2023, no permits have been issued for developers to allow them to damage or destroy any of the Bank Swallow habitat in the Ricardo Ranch area.⁵⁶

There are reasons to believe the federal government may be unwilling to permit damage to or destruction of Bank Swallow habitat. For one, the *Recovery Strategy* makes clear that “the critical habitat identified ... is insufficient to meet the population objectives.”⁵⁷ Further, it notes that “[n]esting habitat in natural settings should be maintained, whether it is occupied or not, to ensure sufficient nesting habitat is available for the Bank Swallow population given the reduction [of] human-made habitat availability.”⁵⁸ Therefore, even if the *RRASP* area is not considered “critical habitat,” it is nesting habitat that must be maintained. This suggests the federal government will impose strict conditions on development to protect this habitat in accordance with the *Recovery Strategy*.

Additionally, the *Recovery Strategy* lists “housing and urban areas” as threats to Bank Swallow nests, as well as their bluff and foraging habitats.⁵⁹ No permits can be issued if development will jeopardize the recovery of the species. Since the proposed development in the *RRASP* area may disturb or destroy Bank Swallow residences, it may be difficult for the developers to obtain such a permit.

4. Presence of Migratory Birds Could Trigger Federal Impact Assessment Process

The *Impact Assessment Act* (“*IAA*”) outlines a process for how the federal government assesses the effects within its jurisdiction of designated projects.⁶⁰ Specifically, the *IAA* states that the federal government can require proponents of certain major projects to conduct federal impact

assessments.⁶¹ Under the *IAA*, the Minister or the Governor in Council must decide, based on the findings of a federal impact assessment, whether the adverse federal effects of a project are in the public interest.⁶² Effects within federal jurisdiction include a change to migratory birds and fish and fish habitat, amongst others.⁶³ If the Minister or the Governor in Council decides that the effects are in the public interest, then they must impose conditions on the project with which the proponent must comply.⁶⁴ If they decide that the effects are not in the public interest, then the proponent cannot proceed with the project.⁶⁵

“Designated Projects” include those listed in the *Physical Activities Regulations* (“Project List”) and those designated by the Minister under subsection 9(1) of the *IAA*.⁶⁶ The Minister may exercise his or her discretionary authority if he or she is of the opinion that the carrying out of the activity may cause adverse effects within federal jurisdiction, or if “public concerns related to those effects warrant the designation.”⁶⁷ The Minister may designate a project on his or her own initiative, or may receive designation requests from the public, Indigenous communities, and non-governmental organizations, amongst others.⁶⁸ The *IAA* prohibits the designation of projects that have “substantially begun,” or which have been authorized under another Act of Parliament.⁶⁹ Moreover, designation requests relating to a plan, policy, or hypothetical activity are not considered.⁷⁰

Both Bank Swallows and Great Blue Herons are migratory birds, as per the *Migratory Birds Convention Act, 1994*.⁷¹ Therefore, any changes, with respect to a physical activity, in relation to these animals fall within federal jurisdiction.⁷² The Project List does not include urban land developments, such as the proposed community of Logan Landing.⁷³ However, a party could request that the Minister designate this development under subsection 9(1) of the *IAA*.

If the Minister designated this development, the *IAA* would be triggered and the proponent would have to proceed to this statute’s planning phase.⁷⁴ This phase requires the proponent to prepare an initial project description, to respond to the issues identified by the Impact Assessment Agency (“Agency”), and to engage in public participation opportunities.⁷⁵ After ensuring that the requirements under this phase have been satisfied, the Agency would then decide whether an impact assessment is required.⁷⁶ Even if the Agency decided that an impact assessment was not

**Open Letter for CPC2023-0295 Logan Landing Land Use
Redesignation Matter in Ricardo Ranch Area Structure Plan**

Overview

On May 16 2023, Calgary City Council will decide whether to approve as proposed, or request modifications to the Logan Landing neighbourhood development adjacent to the Bow River. This development is partly within the river valley, at the southern edge of Calgary, as part of the Ricardo Ranch Area Structure Plan (RRASP). The RRASP was approved for development in 2016, and the Logan Landing neighbourhood by Genesis Land Development is the first of three proposed neighbourhoods in that area to come before Council.

The groups who have signed this letter all work to protect and conserve important habitats throughout Alberta. We collectively oppose the development, as proposed in the application, because it would significantly impact the Bow River's floodplain, the adjacent wildlife corridor, and sensitive habitat contained within the area below the upper plateau.

We believe there is a win-win solution that will allow the Logan Landing neighbourhood to be built with modifications, while better protecting the wildlife habitat and floodplain.

Environmentally Significant Area

The Ricardo Ranch area, containing Logan Landing, is unique because of the convergence of ecosystems in one place and the varied plant and animal species that rely on this ecosystem to survive. Close to the river you will find riparian forest in the transition zone between the river and the upland area, bordered by some of the last natural wetlands in Calgary fed from channels off the Bow River and naturally occurring springs flowing down from the escarpment above. These springs are themselves surrounded by pasture land that contains remnants of what is now rare native prairie grassland.

Unfortunately, 46% of the City-identified Environmentally Significant Areas in the Logan Landing development are proposed to be permanently destroyed. This includes wetlands, of which Calgary has already lost 90%. Natural wetlands are a hugely important ecological asset that help mitigate against the increasingly severe effects of climate change and provide crucial habitat for migratory birds, bats, and amphibians. The Ricardo Ranch area is one of the last places within Calgary where natural wetlands are intact and healthy and we believe Council has an opportunity to ensure many of them remain this way. We recognize that the wetlands on the upper plateau will be removed or compromised to accommodate this development, but the natural wetlands below the upper plateau can be preserved.

Habitat for At-Risk Species

The Ricardo Ranch area provides habitat for Species At Risk. For example, the southernmost point of land in the RRASP, straddling Logan Landing and the adjacent parcel, is home to the last remaining great blue heron rookery (nesting site) in Calgary. Some Calgarians may remember the former rookeries in other parts of Calgary, including in Fish Creek Provincial Park that was abandoned by the herons following development in the surrounding area and significant recreational use of the park. We are concerned that the standards recommended by the federal Committee on the Status of Endangered Wildlife in Canada (COSEWIC) and Alberta Fish and Wildlife for the disturbance radius surrounding heron nesting sites of 1000m was relaxed to 750m to allow this development to proceed as proposed. The build-out of this neighbourhood will occur over multiple years, with loud and large machinery such as excavators, graders, and pile drivers operating within the recommended setback. If this land use proposal is approved without modifications, it is almost certain that this last heron rookery in Calgary will also be abandoned by this threatened species.

In addition to the threatened Great Blue Heron nesting site, the ecological inventory document for the RRASP found that the grasslands and wetlands within the area support the following, all indicating a healthy ecosystem:

- Colonies of bank swallows which are a threatened species that has lost over 98% of its population in Canada and which nest in the slope below the upper plateau;

- Songbirds such as Baird’s sparrow, a species of Special Concern under the Federal Species At Risk Act (SARA) and listed as Sensitive under the provincial Wildlife Act, which nest in grasslands;
- Seven species of bats, including the Federally and Provincially endangered Little Brown Myotis as well as several other species considered at-risk in Alberta that are sensitive to habitat loss and use riparian habitat for both foraging and roosting.

Important habitat for all these species will be lost if the development proceeds without modifications to better protect the river valley, the escarpment, and the wildlife corridor.

Native prairie grasslands are the most endangered ecosystem in Alberta. While the grasslands in the RRASP have been disturbed by historical grazing activities, they are still productive and are supported by the naturally occurring springs located along the escarpment. Preserving more of this ecosystem throughout the RRASP supports larger and more diverse animal populations, increasing its value and resilience.

Smarter Development Required

We know that growth is necessary to provide homes for the ever-increasing population of our city–this is why we do not oppose the development in its entirety. We believe this can be done more efficiently and not at the cost of disturbing and potentially destroying the few healthy, native ecosystems we have left within city limits. Instead, we must be creative and implement best management practices, in order to find ways to build in the areas we already call home, while protecting the areas our native wildlife also call home.

We believe developing the parcels within the Ricardo Ranch Area Structure Plan, as has been proposed, is contrary to statutory documents like the Municipal Development Plan (MDP) 2.3.4 Parks, Open Spaces and Outdoor Recreation, and 2.3.5 Municipal, School, Environmental, and Conservation Reserves, which outlines that the City will “protect, conserve, and restore” environmentally significant areas. This plan also appears to contradict the Climate Strategy and Council’s Strategic Plan for 2023-2026 which focuses on resilience. Climate resilience is a key pillar in this plan as we aim to build a city that recognizes the climate emergency and does its part to limit global warming to 1.5 degrees Celsius. However, we are aware

this developer has proposed to install solar panels on every home in the development, and install electric vehicle charging infrastructure, which we applaud.

Win-Win-Win Proposal

There are options to modify the neighbourhood proposals within the RRASP, including Logan Landing:

- 1) Identified Environmentally Significant Area lands that are not otherwise dedicated as Environmental or Municipal Reserve can be dedicated as Conservation Reserve or
- 2) The developers could negotiate a land swap for part of the lands, donate part of the lands to the city or the province, or enter into a conservation easement agreement with a Land Trust non-governmental organization, with the appropriate benefit of tax credits.

Implementing these options would be a win-win-win scenario, with the sensitive habitat and species better protected, the river able to access its floodplain, and the developers will be able to build a still vibrant, complete community.

Conclusion

Calgary is a city that values its river valleys and wild spaces. We present this to the world as something that makes us unique and are rightly proud of what we have worked to conserve and protect. We have signed the International Durban Commitment for Biodiversity, which reads in part:

“This Commitment recognizes...that the value of biodiversity is multi-faceted - including ecological, economic, tourism, recreational, environmental, heritage, stewardship, spiritual, intrinsic, medicinal, nutritional, health, educational, scientific, cultural and social dimensions.”

By signing this Commitment, the City of Calgary acknowledges its own “accountability and responsibility for the health and well-being of our communities through protecting, sustainably utilising and managing biodiversity and recognizing its role as the foundation of our existence.”

This is exactly why we need to reconsider developing the valley lands within the Ricardo Ranch area, including Logan Landing, as has been proposed, and all future developments in our river valleys. If we don't do so now, we risk losing forever one of the things that helps us define ourselves as Calgarians. With what we know about catastrophic biodiversity loss and climate change, it's time we take our prior commitments seriously and preserve the valuable ecosystems we have left. Let's start with Ricardo Ranch.

Open Letter for CPC2023-0295 Logan Landing Land Use Redesignation Matter in Ricardo Ranch Area Structure Plan

My name is Nathaniel Schmidt. I am a resident of Ward 6 and have been involved with advocating for Ricardo Ranch as a board member of the Alberta Wilderness Association and also a concerned Calgarian.

I support the positions in the joint letter submitted by conservation organisations from Calgary and around Alberta and wished to add my own letter of advocacy from a personal perspective.

Ideally, Logan Landing and all developments attached to the Ricardo Ranch ASP would not be permitted to build below the escarpment and into the river valley below. As the joint letter states, these areas hold great ecological value and help mitigate the effects of climate change and extreme weather events while also supporting rich biodiversity. I saw this myself on the many journeys I took into the publicly accessible areas in Ricardo Ranch.

The following pictures show the range of habitat found in this one location and may help give council perspective about what surrounds these developments:





These photos show grasslands, wetlands, and riparian forest all in the same location. This abundance of relatively healthy ecosystem areas within one spot on the Bow River in Calgary city limits has almost completely been lost.

Combined, they are all extremely valuable in providing climate resilience, especially in the form of extreme weather events. We are seeing continued evidence from experts in Canada and around the world that the engineering of nature is superior to human engineering when it comes to the climate issues we will continue to face.

As you have likely heard, these ecosystems also support an abundance of biodiversity including native plant species and important wildlife:

Regardless of the decision you reach for Logan Landing and future developments in Ricardo Ranch, we must protect, preserve and improve the valuable ecosystems that remain.

I am asking council consider the following:

- Increase the amount of ESA being protected in Logan Landing and all other developments in Ricardo Ranch;
- Dedicate all undeveloped ESAs as natural areas for permanent protection;
- Remain committed to these areas and create a long-term management plan for the remaining ESA in Ricardo Ranch and Seton to preserve and improve existing habitat;

- Restrict human access to these areas and cancel plans to create a Bow River Access Site and Day Use Area in this area of the Bow; and
- Work with the developers to consider alternative plans for long-term management through conservation easements that could include partnerships with regional, provincial or national land trusts.

If we are going to encroach on these healthy ecosystems we must ensure that they are kept intact and given the best chance possible to remain productive. The above proposals would balance the city's desire to develop these areas while protecting what remains.

The public outcry around this issue is a sign that people want change and want to see our leaders take climate change and biodiversity collapse seriously. These issues are no longer only important to environmental groups but to the general public who voted for a council that approved the Climate Strategy.

This is an opportunity for us to show our peers how cities can grow better. The ideas suggested above are not revolutionary but are practical ways we can make positive changes.

If we can't fully save Ricardo Ranch, we can certainly agree to do the next best thing and protect what's left.
