RESIGNATION AND APPOINTMENT – CALGARY PARKING AUTHORITY, N2013-0776 (RECOMMENDATION 2 ONLY)

BACKGROUND:

At the 2013 November 18 and 19 Combined Meeting, Council accepted the resignation of Mr. Brian O'Leary from the Calgary Parking Authority.
