INDUSTRIAL, COMMERCIAL AND INSTITUTIONAL (ICI) WASTE DIVERSION STRATEGY DEFERRAL REPORT

EXECUTIVE SUMMARY

The development of comprehensive sector strategies is a vital element of continued progress toward the 80/20 by 2020 target. Waste and Recycling Services (WRS) is developing an ICI Waste Diversion Strategy that will guide and direct the diversion of ICI materials from landfills.

The second phase of engagement activities that will contribute to the strategy were rescheduled due to industry stakeholder involvement in the 2013 flood event. The final phase of stakeholder engagement is currently underway and will be finalized in 2014 February.

WRS is requesting a deferral of this strategy report on ICI until 2014 April.

RECOMMENDATION(S)

That the SPC on Utilities and Corporate Services recommend to Council:

1. Approve the deferral of the Industrial, Commercial and Institutional Waste Diversion Strategy to no later than 2014 April.
