

## **Status of Non-Standard and Tri-Party Agreements Expiring on or before 2013 Dec 31**

### **Non-Standard Agreements**

Non Standard Agreements contain substantive changes that are outside of the Council approved Lease/License of Occupation Policy for Community Organizations. These agreements must be approved by Land and Asset Strategy Committee and/or Council.

The YMCA has the option to buy the lands on which the Recreation Facility is located on July 1 <sup>st</sup> 2025. There are two additional agreements Party Wall Agreement and Operating Agreement between The City of Calgary and YMCA.	August 31 <sup>st</sup> 2010 in overhold
Southern Alberta Pioneers	25 year agreement with an option to renew for an additional 25 years.	June 30 <sup>th</sup> 2010 in overhold

### **Tri-Party Agreements**

A Tri-Party Agreement is between The City, community organization and either the Calgary Board of Education (CBE), the Calgary Catholic School District (CCSD) or both. The following Tri-Party Agreements are in alignment with the new standard form agreements and will be completed and executed by the end of December 2013:
