Background

The Advisory Committee on Accessibility ("ACA") provides strategic advice and makes recommendations to Council and City Administration in addressing issues, needs and services for people with physical, sensory and cognitive disabilities including, but not limited to: built environment, accessible transportation and transportation infrastructure, technology, information and communication, goods and services, affordable/accessible housing, social and economic accessibility issues in order to provide high level accessible City services for people with disabilities.

On 2023 May 11, the ACA administrative resource informed the City Clerk's Office of the passing of Public Member Christopher Gordon, and expressed the desire to fill the resulting vacancy.
