RE: Addressing Foxtail Barley - CD2023-0374

BILD Calgary Region ("**BILD**") is a non-profit organization that has a membership base that includes all facets of residential home and commercial construction, including builders, renovators, developers, trades, suppliers, and professional companies involved in the building industry. We advocate for affordability, choice, and innovation in the building industry.

On behalf of our members, we are writing this letter to express our concerns regarding the proposed changes to the Community Standards Bylaw pertaining to the enforcement of Foxtail Barley control measures. BILD's membership was provided with the proposed amendments to the Community Standards Bylaw on June 21, 2023, and advised that the changes would be presented to Council Committee at its June 28, 2023, meeting. This timing has not afforded BILD and its members sufficient time to adequately review the proposed amendments to the Community Standards Bylaw.

We respectfully request additional time to better understand the details of the requirements and how the amended Community Standards Bylaw would be implemented for property owners, builders, and developers depending on the location, size, stage of development, and to communicate to our membership the necessary steps to adhere to the amended Community Standards Bylaw. This extension will provide BILD members and other impacted stakeholders with the necessary time to meaningfully assess the implications of the proposed changes to the Community Standards Bylaw and better engage in constructive dialogue with City Administration to ensure that any changes to the Community Standards Bylaw aligns with the best interests of all impacted stakeholders.
