BACKGROUND

Each December, the Business Revitalization Zones (BRZ) make appointments to their Boards of Directors for the upcoming calendar year and subsequently forward the names to Council for appointment, as per the *Municipal Government Act* (MGA) Section 51 (1) as follows:

"51 (1) A business revitalization zone is governed by a board consisting of members appointed by council under the business revitalization zone bylaw."

The City of Calgary has ten Business Revitalization Zones (BRZ) and each BRZ is governed by a business revitalization zone bylaw.

As per Bylaw 41M2003, each Bylaw requires that BRZ's shall consist of not more than ten (10) individuals, appointed by Council, each of which shall have been nominated by any person, including a corporation, liable for municipal assessment within the BRZ.

Following the Annual General Meeting for each BRZ, their yearly financial statements and membership is forwarded to the City of Calgary's Finance and Supply business unit. City Clerks then forwards the membership of the various BRZ Boards of Directors to Council for their approval as per the Attachment.
