In addition to Council's direction in 2008, that the Special Meeting of the SPC on Community and Protective Services sitting as the FCSS Review Board be scheduled on the calendar, Administration has requested that, for 2014, the annual Special Meeting of the SPC on Community and Protective Services, Re: Civic Partner Presentations also be included.

BACKGROUND

Please note that the following factors were taken into consideration.

Regular Council Meetings

There will be two regularly scheduled Council meetings per month. The first meeting will be a Combined Meeting of Council (Statutory Public Hearings on Land Use Items and Regular meeting items); the second meeting of the month will be a Regular Business meeting dealing primarily with Committee reports. The Tuesday following a Council meeting has been set aside as an overflow day, if necessary, with a commencement time of 1:00 p.m., unless changed by Council resolution (Two-Thirds Vote).

Strategic Planning Meetings, if required

Strategic Planning Meetings of Council are scheduled, if required.

Standing Policy Committee (SPC) Meetings

With respect to Special Meetings of the SPC on Community and Protective Services, due to the duration of these meetings in the past, and the high rate of participation by Agencies and members of the public, the Administration has requested that these meetings be given an early start time. The following is being proposed on the attached calendar scenario:

- On 2014 March 05, the Special Meeting of the SPC on Community and Protective Services sitting as the FCSS Review Board to begin at 9:30 a.m.; and
- On 2014 June 04, the Special Meeting of the SPC on Community and Protective Services, Re: Civic Partner Presentations to begin at 9:30 a.m.

The Regular SPC on Community and Protective Services Meetings on March 05 and June 04 will commence immediately following the adjournment of the Special Meetings.

Special and Audit Committee Meetings

All Special Committees and Audit Committee are scheduled for meetings on Thursdays. During some months, it was necessary to schedule two Committees on the same Thursday. On these days, the top Committee would commence at 9:30 a.m. and the bottom Committee would commence at 1:00 p.m.

The Audit Committee Bylaw 48M2012 requires that the Audit Committee meet at least eight times per year. At the request of the City Auditor, ten Audit Committee Meetings have been scheduled for the year, omitting meetings in February and August.

Statutory Holidays

It has been necessary to schedule some meetings during weeks where statutory holidays occur in order to enable committees to complete their monthly business.

The Spring Breaks for the Calgary Public and Separate School Boards are scheduled from 2014 March 24 to March 28, and those days have been kept clear of meetings.

FCM Conference

The Federation of Canadian Municipalities Annual Conference is scheduled for 2014 May 30 to June 2 in Niagara Falls and those days are clear of meetings.

Calgary Exhibition and Stampede

The Calgary Exhibition and Stampede is scheduled for 2014 July 4 to 13, and those days have been kept clear of meetings.

August Break

To ensure a break in August, no Council or Committee meetings have been scheduled. All SPC meetings in July have been scheduled so that they report (some as Urgent Business, if required) to the last Regular Meeting of Council on 2014 July 28 before the summer break.
