In response to Motion brought forth by the WHCA Transportation and Mobility Committee:

It is with a great deal of pleasure that I am writing this letter to support the naming of the 21<sup>st</sup> Street NW pedestrian bridge to the Bev Longstaff West Hillhurst Pedestrian Bridge. As a former Mayor of Calgary, I can think of no better way to honour a woman who is the personification of servant leadership within her community and to the entire city of Calgary. I worked closely with Bev through my four terms as Mayor and found her passion and commitment to Calgary knew no bounds. Bev was always there and willing to address the big challenges, whether it be advocating for a critical community project, like the 21<sup>st</sup> Street bridge, or leading larger social and community issues, like the Mayor's Task Force on Family and Community Violence and its successors. She was a trusted advisor, and someone I could always rely on to help navigate complex issues.

While Bev had a long history of community advocacy and leadership including the Hillhurst Sunnyside Community Association and the Federation of Calgary Communities, it was her ability to get things accomplished that differentiated her work. The 21<sup>st</sup> Bridge is probably the best example, providing a permanent, safe connection between the community of Hillhurst Sunnyside and the Calgary's signature river pathways system.

Bev's contributions to Calgary were not limited to physical improvements. A strong sense of social justice prevailed in all her decisions, defining her work. One of the most important initiatives during our terms in office was the establishment and implementation of the Mayor's Task Force on Community and Family Violence. From the very beginning, Bev served as a personal advisor and mentor, including participating as a Task Force member through its implementation, which was a personally challenging and deeply emotional exercise. The Task Force's extensive community consultation, connection, and coordination with the over 80 organizations in this space, along with many individuals impacted by family violence, resulted in every one of the Task Force's 66 recommendations being implemented during our terms of office. While the Task Force carried the name of the office of the Mayor, Bev was an indispensable and influential leader through this process, an active participant in the follow up including the continent leading HomeFront community justice initiative. As Mayor my motto was 'strong people make strong cities', and Bev was not only a strong woman herself, she helped our most vulnerable find their voice and purpose so they too could be strong contributors to Calgary.

I have nothing but the utmost respect and admiration for Bev and all that she has done for my City, and our broader community. Renaming the 21<sup>st</sup> Street bridge would be a long overdue recognition of one of the most hardworking and inspirational female leaders Calgary has known. The Bev Longstaff West Hillhurst Pedestrian Bridge will be a lasting legacy, and a lasting tribute to a true community leader.

The letter is in support of the community and neighbourhood campaign to name the 2 1 St NWpedestrian overpass and bridge to the:

#### Bev Longstaff-West Hillhurst Pedestrian Bridge

I worked as Ms. Longstaff's Executive Assistant from 1992 to 2001 and know first-hand what an effort Bev undertook to make this pedestrian bridge a reality. She championed the bridge construction with City Administration and her Council colleagues to approve the budget.

Bev advocated for City of Calgary Engineer Jadwiga Kroman to be the lead designer on the project (a rarity for a woman to lead projects in the 1990s). Ms. Kroman created a beautiful sweeping structure that feels safe as well as elegant.

Bev liaised with the late Bill Milne, the architect and designer of the bridge under Crowchild Trail to complete the circuit from north side of the Bow River to south which was constructed with private donations. This ensured that flow and extensive pedestrian use was achieved in tandem with both bridges. Bev used her connections to physically connect both sides of the Bow River. What a success!

Opening the bridge was one of the last achievements Bev did for her constituents and for Calgarians before her political career was completed in 2 0 0 1 . I remember balloons, music, hot dogs and lots offamilies on bikes, trikes, skateboards, and with baby carriages or walkers. We all gathered around to witness the cutting of the ribbon to officially open access to the Bow River Pathway from our neighbourhood.

And what a pathway! Calgary is the envy of the world to have such an extensive pathway system showcasing our beautiful riverbanks and providing not only transportation options but a source ofhealth and wellness for Calgarians. And now with the pedestrian overpass, accessing this pathwayfrom the north side of Memorial Drive is safe and well utilized.

I raised my family in Hillhurst with my daughters attending Hillhurst Community School and then Queen Elizabeth High school. And THAT is another reference for the apt naming of this pedestrian bridge. Bev grew up in Hillhurst and attended Queen Elizabeth HS along with her four siblings. Herphoto is still on the wall in the hallways; she is truly a Hillhurst/West Hillhurst icon and champion.

Recognizing her efforts and commitment and vision by adding her name to the bridge is a gesture that is perhaps long overdue - so lets' do this in her lifetime!
