Background and Planning Evaluation

Background and Site Context

The subject site is located in the northwest community of Montgomery and is a mid-block parcel located on 19 Avenue NW between 48 Street NW and 49 Street NW. The parcel is approximately 0.06 hectares ± (0.14 acres ±) in size and is approximately 15 metres wide and 35 metres deep. The parcel is currently developed with a single detached dwelling with a detached garage, and lane access is available along the south side of the site.

The subject site is currently designated Residential – Contextual One Dwelling (R-C1) District and is surrounded by single detached dwellings designated R-C1 District and Residential – Contextual One / Two Dwelling (R-C2) District. To the east of the site on 19 Avenue NW, are parcels that were redesignated in 2016 to the Residential – Grade-Oriented Infill (R-CG) District as part of a City initiated Main Streets Project.

The subject site is located approximately 150 metres (two-minute walk) from the Bowness Road NW Neighborhood Main Street. The site is also located approximately 450 metres (six-minute walk) from the Trans-Canada Highway (16 Avenue NW) and 300 metres (four-minute walk) from the Terrance Road School, a Calgary Board of Education Kindergarten to Grade 6 school. Shops, restaurants and other commercial services are located near the subject site along Bowness Road NW and 16 Avenue NW. Other nearby amenities include the Shouldice Athletic Park, located 1 kilometre (13-minute walk), Shouldice Park, located 1.5 kilometres (18-minute walk) and The Montgomery Community Association, located 500 metres (seven-minute walk) from the subject site. The subject site is also well serviced by public transit along Bowness Road NW, Home Road, 48 Street and 16 Avenue NW.


As identified below, the community of Montgomery reached its peak population in 1969.





Planning Evaluation

Land Use

The existing R-C1 District is a low-density residential designation that is applied to developed areas and is primarily for single detached dwellings that may include a secondary suite. The R-C1 District allows for a maximum building height of 10 metres and a maximum density of one dwelling unit. Secondary suites are discretionary uses within the R-C1 District.

The proposed R-C2 District is a low-density residential designation that is applied to developed areas and is primarily for single detached dwellings, semi-detached dwellings and duplex dwellings. The proposed district allows for a maximum building height of 10 metres and a maximum of two dwelling units. Secondary suites are permitted uses under the R-C2 District and do not count towards the allowable density of the site.

Development and Site Design

The rules of the proposed R-C2 District would provide guidance for the development of the site, including the appropriate uses, building height and massing, landscaping, parcel coverage and parking.

Transportation

Pedestrian access to the site is available from existing sidewalks along 19 Avenue NW.

The subject site is well-served by Calgary Transit. The subject site is approximately 80 metres away (2-minute walk) from the transit stop for bus Route 422 (Dalhousie) on 48 ST NW and approximately 300 metres away (4-minute walk) from the transit stop for bus Route 1 (Bowness), Route 40 (Crowfoot Station), Route 53 (Greenwood), Route 305 (City Centre). The transit stop for bus Route 53 (Brentwood Station), Route 408 (Brentwood Station) and Route 422 (Dalhousie) are located approximately 300 metres away (4-minute walk) on Home Road NW.

The subject site is 230 metres (three-minute walk) from the existing on-street bikeway, which is part of the Always Available for All Ages and Abilities (5A) Network on Home Road NW.

A Transportation Impact Assessment was not required as part of this application.

Environmental Site Considerations

No environmental concerns were identified.

Utilities and Servicing

Water and sanitary sewer mains are available to service the subject site. Details of site servicing, as well as appropriate stormwater management will be considered and reviewed as part of the development permit review stage.

Legislation and Policy

South Saskatchewan Regional Plan (2014)

Administration's recommendation aligns with the policy direction of the <u>South Saskatchewan</u> <u>Regional Plan</u> which directs population growth in the region to cities and towns, and promotes the efficient use of land.

Growth Plan (2022)

Administration's recommendation aligns with the policy direction of the Calgary Metropolitan Region Board's <u>Growth Plan</u> (GP). The proposed land use amendment and policy amendment builds on the principles of the GP by promoting efficient use of land and regional infrastructure, and establishing strong, sustainable communities.

Municipal Development Plan (Statutory – 2009)

The subject site is located within the Developed Residential – Inner City area as identified in Map 1: Urban Structure in the <u>Municipal Development Plan</u> (MDP). The applicable MDP policies encourage redevelopment and modest intensification of inner-city communities to make more efficient us of existing infrastructure, public amenities and transit and deliver small and incremental benefits to climate resilience.

The proposal is in keeping with relevant MDP policies as the rules of the R-C2 District allow for development forms that are low density in nature and are sensitive to the existing residential development in terms of building height, scale and massing.

Calgary Climate Strategy (2022)

This application does not include any actions that specifically address the objectives of the <u>Calgary Climate Strategy – Pathways to 2050</u>. Further opportunities to align future development on this site with the applicable climate strategies will be explored and encouraged at the development permit stage.

Montgomery Area Redevelopment Plan (Statutory – 2005)

The <u>Montgomery Area Redevelopment Plan</u> (ARP) identifies the subject site as Low Density Residential on Figure 1.3: Future Land Use Plan. The Low Density Residential policies of the ARP discourage the redesignation of residential parcels from R-C1 to R-C2 in an effort to secure stability and maintain the character of the neighbourhood. The ARP was created prior to the adoption of the Municipal Development Plan in 2009 which encourages modest intensification of inner-city communities. Minor text amendments to Policies R4 and R5 in the ARP are proposed to accommodate the land use redesignation.

South Shaganappi Community Local Area Planning Project

Administration is currently working on the <u>South Shaganappi Community Local Area Planning Project</u> which includes Montgomery and surrounding communities. Planning applications are being accepted and processed during the local area planning process.
