BYLAW NUMBER 47M2023

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 26M96, THE CALGARY TRAFFIC BYLAW

WHEREAS Council has considered IP2023-0910 and deems it necessary to amend the Calgary Traffic Bylaw 26M96;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. The Calgary Traffic Bylaw 26M96, as amended, is hereby further amended.
- 2. Section 2 is amended by deleting:
 - (a) the definition of "metered space" in section 2(1)(y);
 - (b) the definition of "parking meter" in section 2(1)(ac); and
 - (c) the definition of "ticket controlled space" in section 2(1)(ar.1).
- 3. Section 2.2 is amended by:
 - (a) adding the following at the end of subsection 2.2(2) after the word "Council":"unless excluded by Council in the Calgary Parking Policies"; and
 - (b) adding the following after subsection 2.2(3) as subsection 2.2(4):
 - "(4) The *Director, Mobility* may establish fees governing the management of the City's impound lots including:
 - (a) towing charges (flat and mileage);
 - (b) administration fees (such as check-in fees, registered letter fees, lien check fees and other similar charges);
 - (c) storage fees;
 - (d) lot movement fees;
 - (e) VIN assignment fees; and
 - (f) disposal fees (including cleaning of contents and hazardous materials).".
- 4. Section 9 is amended by:

- (a) deleting subsections 9(7)(a)-(c), 9(8), 9(9)(a)-(c), 9(19), 9(20), and 9(21)(a);
- (b) adding the words "allow a vehicle to", after the words "No owner or *operator* shall" in subsection 9(14);
- (c) deleting the words "wholly within the *metered space*, *ticket controlled space* or" in subsection 9(17)(a) and substituting in its place:
 - "completely within the";
- (d) deleting the words "whether a *metered space* or a *ticket controlled space*," from subsection 9(18);
- (e) deleting the words "a *metered space*, a *ticket controlled space* or" from subsection 9(21); and
- (f) adding the following after subsection 9(22) as subsection 9(23):
 - "(23) No owner or *operator* shall allow a vehicle to remain in a *zone controlled* space where the licence plate of that vehicle is obscured so as to be unreadable to a parking enforcement camera.".
- 5. Section 20 is amended by:
 - (a) adding the words "Select Permit," to subsection 20(c) after the words "Residential Parking Permit,"; and
 - (b) deleting the words "or has less than 20 dwelling units" in subsection 20(e) and substituting:
 - "and has 20 or fewer dwelling units".
- 6. Section 34 is amended by:
 - (a) deleting the words "twenty (20) minutes" from subsection 34(1)(b) and substituting in its place:
 - "the period of time allowed by the applicable *traffic control device*";
 - (b) deleting the words "ten (10) minutes" from subsection 34(2) and substituting in its place:
 - "the period of time allowed by the applicable traffic control device";
 - (c) deleting the words "twenty (20) minutes" from subsection 34(4) and substituting in its place:
 - "the period of time allowed by the applicable traffic control device"; and

(d) deleting the words "ten (10) minutes" from subsection 34(6) and substituting in its place:

"the period of time allowed by the applicable traffic control device".
