Public Member Appointments to Calgary Salutes Committee, Saddledome Foundation and Ward Boundary Commission

PURPOSE

This Report presents applications from individuals seeking appointment as Public Members on the Calgary Salutes Committee, Saddledome Foundation and Ward Boundary Commission. The Nominations Committee is asked to shortlist candidates and recommend Public Member appointments to Council, for its consideration at the annual Organizational Meeting on 2023 October 24.

PREVIOUS COUNCIL DIRECTION

In accordance with Procedure Bylaw 35M2017 and Council policy CP2016-03, *Governance and Appointments of Boards, Commissions and Committees,* the Nominations Committee is responsible for making recommendations to Council on Public Member appointments and nominations.

DISCUSSION

The Nominations Committee is asked to review the applications (Confidential Attachments 1c-3c), short list candidates and recommend Public Member appointments to Council, for its consideration at the annual Organizational Meeting on 2023 October 24. The Nominations Committee may sit in smaller panels to interview candidates and make recommendations to Council.

Calgary Salutes Committee

There are 26 Public Member vacancies on the Calgary Salutes Committee, including eight Friends of HMCS Calgary Subcommittee vacancies, nine Education and Training Subcommittee vacancies, and nine Heritage and History Subcommittee vacancies.

Ward Boundary Commission

There are five vacancies requiring Public Member appointments to the Ward Boundary Commission for terms ending at the date the Commission's final recommendations report is presented to Council.

Saddledome Foundation

There is one Public Member vacancy on the Saddledome Foundation due the expiry of a current Public Member's term. Members of the Saddledome Foundation must appoint Council's nominee to the Board of Directors.
