Calgary RECOMMENDATIONS

That the Nominations Committee short list Public Member candidates to serve on the Calgary Salutes Committee, Ward Boundary Commission and Saddledome Foundation, and further, recommend that Council:

- 1. Appoint Public Members to the Calgary Salutes Committee and Ward Boundary Commission for terms set out in Confidential Attachments 1a and 3a;
- 2. Direct Administration to forward the name of the nominated Public Member to the Saddledome Foundation for appointment to the Board of Directors for a three-year term expiring at the 2026 Organizational Meeting of Council;
- 3. Direct that Public Member appointments to the Calgary Salutes Committee and Ward Boundary Commission be released publicly following applicant notification by the City Clerk's Office, no later than end of day Friday, 2023 October 27;
- 4. Direct that the Public Member nomination to the Saddledome Foundation be released publicly following their appointment by the Saddledome Foundation;
- 5. Authorize the destruction of all confidential ballots; and

The Calgary Salutes Committee is newly-established and has no Chair to screen and short-list applicants.




WARD BOUNDARY COMMISSION
