
Administration's Recommendations

Disposition Options

Option 1

Authorization to negotiate a sale by direct negotiation with the Muslim Community Foundation of Calgary at market value;

Option 2

Option 3

Authorization to negotiate a sale by direct negotiation with the Muslim Community Foundation of Calgary at nominal value plus transaction fees and all associated transaction costs;

Option 4

Do not proceed with a transaction with the Muslim Community Foundation of Calgary.
