Emergency Management Committee Risk Engagement

The Emergency Management Bylaw requires the Calgary Emergency Management Agency (CEMA) to provide a Status of Emergency Preparedness Report annually to Emergency Management Committee. In addition, two reports and panel presentations are provided each year to allow meaningful conversations and ensure Emergency Management Committee and Calgarians are well-informed on actions taken to address high risks for Calgary. Reports are received for the corporate record and inform the annual Status of Emergency Preparedness Report. A timeline of these reports is outlined on page 2 of this attachment.

Related Bylaws and Regulations

Emergency Management Bylaw 25M2002

The municipal bylaw that guides Calgary Emergency Management Agency.

Province of Alberta Emergency Management Act

Provincial legislation that sets the requirements for Calgary to have an Emergency Management Committee and Agency.

Local Authority Emergency Management Regulation

Provincial Regulation under the Emergency Management Act that provides direction on emergency management roles and responsibilities and what is required of municipalities to plan and prepare for the safety of their community.
