BYLAW NUMBER 55M2023

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 29M97, THE TEMPORARY SIGNS ON HIGHWAYS BYLAW

WHEREAS Council has considered EC2023-0976 and deems it necessary to amend the Temporary Signs on Highways Bylaw 29M97;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 29M97, the Temporary Signs on Highways Bylaw, as amended, is hereby further amended.
2. Section 3.3 is amended by:
 - (a) deleting the word “or” at the end of subsection 3.3(e);
 - (b) deleting the period “.” at the end of subsection 3.3(f)(ii) and substituting:
“; or”; and
 - (c) adding the following after subsection 3.3(f)(ii) as subsection 3.3(g):
“(g) within 2 metres of a driveway crossing or entrance to private property.”.
3. Section 11 is amended by deleting subsections 11(1) and 11(2) and substituting the following in their place:
“11. (1) The Traffic Engineer may, without notice to the Owner of the Sign, remove, impound, or dispose of any Sign that:
 - (a) impedes or interferes with the work of a City operation; or
 - (b) contravenes a provision of this Bylaw.(2) The Traffic Engineer may make policies governing the removal, disposal and impounding of Signs under subsection (1) above.”.
4. Section 12 is amended by adding the following after subsection 12(5) as subsections 12(6) and 12(7):
“(6) Where any Person has been convicted of a contravention of the same provision of this Bylaw twice within a twenty-four (24) month period, the specified penalty payable in respect of the second conviction is double the amount shown in Schedule “A” of this Bylaw in respect of that provision.

- (7) Where any Person has been convicted of a contravention of the same provision of this Bylaw three or more times within a twenty-four (24) month period, the specified penalty payable in respect of the third or subsequent conviction is triple the amount shown in Schedule “A” of this bylaw in respect of that provision.”.
5. Schedule “A”, Minimum and Specified Penalties, is deleted in its entirety and the following is substituted:
