I am writing today to ask that we increase the budget for separated (on-street and offstreet) wheeling infrastructure. This aligns with Calgary's climate goals and will contribute to our ability to become a net zero city.

It can be upsetting to see the city resurfacing corridors like 5/6 Ave NW without adding wheeling infrastructure. Citizens are frequently told to be patient and that things will be improved as a part of larger projects. For this reason it can be especially frustrating when time and time again these improvements are not included in these projects. In some cases it was already decades since the last time the street was resurfaced so it feels like not only do we lose the opportunity for change today, but that now we might not see those positive changes on that street for decades to come.

This is why I am disappointed to see the proposed adjustment to increase funding for the pavement rehabilitation program to 'build back better' being cut in half. This will further slow down the already slow progress on this urgently needed type of infrastructure.

I believe it's appropriate for these items to receive a meaningful amount of increased funding that reflects the urgent need for this type of infrastructure. There are many people who would like to make these choices to use different types of transportation but they feel like the city is not keeping up with the infrastructure to support them. Transportation is one of the biggest contributors to carbon in the atmosphere and therefore has potential to be one of the biggest changes we can make as a city to progress toward net zero. I believe government needs to be there to support people making decisions to live a greener lifestyle. It's hard to imagine how we are going to incentivize people to make better decisions if we struggle to even support the people who are doing it willingly and already want to be part of the solution.

Dear Mayor Gondek and members of Council:

I am a homeowner in Ward 7 having recently moved from Ward 14 early in 2023.

When someone is asking for more money I feel it is incumbent to ask, "what are you doing with the existing money you are given?"

This Council does not appear to value the public trust to manage existing funds it is already entrusted with.

There are myriad numbers of examples of poor management and lack of accountability across the City. That said, I can only comment on the ones in my direct line of sight.

Downtown Calgary has been taken over by vagrants, druggies and people with no qualms about yelling, spitting or hitting Calgarians trying to go about their lives. Daily I see people urinating as well as openly smoking crack with impunity on street benches, on the Plus 15 and on the CTrain.

Calling the City 311 is an exercise in futility because by the time you navigate through a pushbutton directory and listen to warnings that you can't hurt people's feelings, you've either given up or the emergent situation is long past.

For some reason it seems this Council has, through lack of enforcement and consequences, made it acceptable for people to abandon any semblance of personal and civic responsibility and made it socially acceptable to behave poorly, do drugs, and generally run the downtown into a deteriorating state.

I urge this Council to re-focus its priorities and to clean up the drugs and social disorder that has taken over our downtown.

Further, on a number of occasions now I have driven or walked by City of Calgary "workers" where, more often than not, there are at least double the number required and most all of them are standing around watching someone else make an anemic effort at appearing like they're doing work!

Recently, what appeared to be a relatively simple cleanup to pry the melted plastic and garbage off the Kerby West train platform, it had 5, FIVE!, City of Calgary workers who were doing what would have likely taken me 20 minutes to clean up. This is not hyperbole - this was a very simple clean up job.

It bears mentioning that parked around the corner was a totally kitted out new City of Calgary Dodge 5500 six ton service truck, likely worth just shy of \$200,000. Additionally, it's common when I'm standing on the train platform to see an "Out of Service" train go by with one driver (presumably under training) and 4 people standing behind them. Why does it take 4 people, presumably all on salary, to train a driver?

In closing, I have lived downtown Calgary now for almost a year. During that time, the Peace Bridge has been behind chain-link barriers and undergoing renovations to fix broken glass for upwards of 6 months (who picks glass to go where you know it's going to get smashed!!). Poor public design choices aside; why does it take half a year to do a simple removal and replacement? While not definitive, this would certainly appear to be an indicator of a poorly run public works department.

Seeing as all orders of government are asking for more but ratepayers seem to be getting less, I feel increasingly motivated to ask Council the question; why are you asking ratepayers for more money when it's demonstratively accurate through observation to say you are not deploying the existing funds you are given in an efficient nor socially effective manner?

I don't think Council should be contemplating asking for more money for ratepayers. Before doing so, Council needs to demonstrate a better use of the existing funds it receives and focus on the core responsibilities of municipal government — ensuring safe communities and delivering core services in an efficient, effective manner.
