The representative from the Bowness Community Association (BCA) mentioned that BCA would not support this application, but also said; "the city is not bound by the committee's recommendation, and that similarly rezoned projects may still have been approved in the past."

Ward 1 Councillor Sonya Sharp's office asked for details and information about the application, which were provided.

The neighbors had mixed reactions to the proposed Land Use Re-designation. As expected, some were against more density/development, while others thought it would be a good idea to increase density and help prevent urban sprawl. Some thought it would help increase their property values

How did stakeholder input influence decisions?

The neighbors had mixed reactions to the proposed Land Use Re-designation. As expected, some were against more density/development, while others thought it would be a good idea to increase density and help prevent urban sprawl. Some were worried about parking issues. Some thought it would help increase their property values. A couple of the neighbors asked us to add "green infrastructure" to the development.

We assured neighbors that the proposed development would have its own parking stalls on the property, thereby reducing the need for off-property parking. Because we were asked to add "green infrastructure" we decide to add things such as 'low flush toilets', LED lighting, upgraded insulation, solar panels, etc.
