Adopt, by resolution, the proposed street name: Heartwood.

# RECOMMENDATION OF THE CALGARY PLANNING COMMISSION, 2023 NOVEMBER 16:

That Council adopt, by resolution, the proposed street name: Heartwood.

#### **HIGHLIGHTS**

- This application proposes the additional street name, Heartwood, in the community of Rangeview.
- Administration recommends approval of the proposal as it complies with the Municipal Naming, Sponsorship and Naming Rights Policy.
- What does this mean to Calgarians? Municipal naming of streets plays an important role in simple and unambiguous identification for location and navigation within Calgary.
- Why does this matter? The proposal will assist citizens and emergency services
  operators with navigation to and within the developing community of Rangeview by
  allowing for unique street names in the community.
- Heartwood is an additional street name for the area related to outline plan and land use redesignation application LOC2021-0073, approved by Calgary Planning Commission on 2022 March 24.
- The community name of Rangeview was adopted on 2018 December 10.

#### DISCUSSION

This application in the western part of the community of Rangeview, was submitted by Situated Consulting Corp. on behalf of Rohit Land Development on 2023 September 22. The site is south of 196 Avenue SE, west of 88 Street SE and east of 52 Street SE. Location maps can be found in Attachment 1.

The proposed street name, Heartwood, will be used in the area covered by LOC2021-0073 located in the western part of Rangeview as shown in Attachment 2. It is surrounded by the developing communities of Mahogany and Seton.

The proposed name of Heartwood is inspired by the dense inner part of a tree that yields the hardest timber known as heartwood. Heartwood is a distinct name and does not exist in Calgary and surrounding area.
