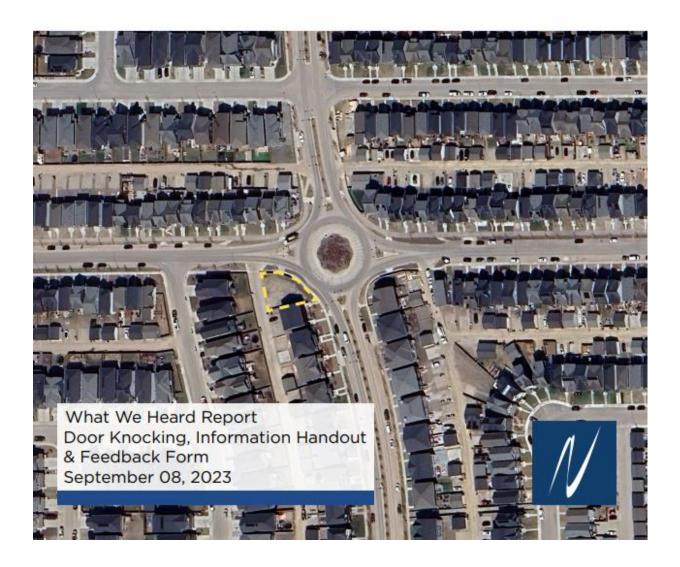

SECTION 1 WHAT WE DID

1. WHAT WE DID

1.1 Overview

The outreach tactics and techniques completed for this application were selected in accordance with the City of Calgary's Community Outreach Assessment Tool. The Tool provides guidance on what the outreach considerations should be for the application based on its impact on the community. The Community Outreach Assessment Tool completed by Invistec is in Appendix I. With the help of the Tool, the following outreach techniques were completed:

- · Community door knocking
- Information Handout
- Online Feedback Form

1.2 Information about Outreach

On July 18 between 2:30pm and 5:00pm, Invistec knocked on the doors of approximately 80 residents in nearby / immediate proximity to the subject redesignation site. Specifically, Invistec knocked on the doors of houses in Figure 1 on the following page. The door knocking involved providing an information handout to residents, listening and noting any comments or concerns, and discussing the land use redesignation application with them. The handout included a QR code for an online feedback form and Invistec's e-mail where residents could provide any comments or questions. The handout is in Appendix II.

The handout informed the impacted residents while the form link further consulted and involved Mahogany residents as they are able to express any further comments or questions they have in the form.

The Copperfield-Mahogany Community Association was also engaged and notified about the land use redesignation by e-mail on July 12, 17, and 20, 2023 and a phone conversation on July 25, 2023 at 4:41pm. The e-mail correspondence is in Appendix II.

2.1 WHAT WE HEARD

The themes from the feedback received from the public outreach include:

- Some residents supported the opportunity to have a daycare in the neighbourhood, especially in close proximity to their houses as child care facilities are currently limited and they would be able to easily pick-up and drop-off their children.
- Some residents had questions and concerns about the VRBO nearby, amount of traffic and street parking due to pick-up and drop-off of up to 50 children.

2.2 CLOSING THE LOOP

Currently, the application is at the land use redesignation preparation stage and items such as number of parking stalls and the number of children that may be accommodated would be determined at the later development permit change of use stage. This means details such as the number of children at the facility would be determined based on how many available parking stalls can be provided for on-site, which is informed through the City of Calgary Land Use Bylaw and the Child Care Service Policy and Development Guidelines.

Invisted is sharing this What We Heard Report with the Community Association as well as those resident(s) who have requested to be kept apprised on the progress of the application.

2.3 NEXT STEPS

Invisted appreciates the opportunity to have engaged in-person through the community door-knocking process, as well as through email and telephone communications. The next steps involve completion of the application, which will then be prepared and submitted to the City of Calgary.

Once submitted, a neighbour notification / notice is posted and the file is distributed within the City of Calgary for review and circulation. Following review, the Calgary Planning Commission (CPC) reviews the application and provides a recommendation to Council. A public hearing will be held and affected area landowners will be notified of the public hearing date by the City of Calgary in advance. The Public Hearing will allow residents and other interested stakeholders the opportunity to voice their support or concerns regarding the application.

Background

Invisted Consulting Ltd. has been retained by Treasured Seeds (the landowner) to redesignate 940 Mahogany Blvd SE to support Child Care Services (a daycare) on the parcel.

Application Overview

The application will redesignate the site from its current land use district of Residential - Low Density Multiple Dwelling District (R-2M) to a Direct Control Provision (DC) that adds Child Care Services as a Discretionary Use. The proposed future development will take the built form of a single detached home, and will be used to support Child Care Services only.

Next Steps

Invistec Consulting has begun preparing the land use redesignation application and is conducting community outreach with local neighbours as well as engaging with the Community Association. Once the application is completed it will be submitted to the City of Calgary for review. A future public hearing will be held and affected area landowners will be notified of the public hearing date by the City of Calgary in advance.

Daycare Attendance

The Child Care Facility will accommodate approximately 50 children, however the ultimate number will be confirmed at the time of Development Permit and will contemplate key design considerations, including parking (contained on-site) and play space.

2023/8/18 3:53 PM	There is NO way we can support this kind of traffic for a daycare of ANY size. We already have a significant traffic and pedestrian traffic issue with the apartment buildings that should never have been allowed to be built where they are. Please do not add to the issue by putting additional strain on this section of the neighbourhood.
2023/8/18 3:55 PM	There's no way we are able to support the traffic. There was already an additional 500 occupants that were already added from the apartment buildings. Where are they supposed to park? Also where would the drop off and pickup zone be. Being a school pickup and drop off zone for the buses that support the area. I am strongly opposed to re zoning this area as a day care location.
2023/8/18 4:03 PM	This will increase traffic, at an already busy traffic circle, that nobody pays attention while in. As a frequent pedestrian at this traffic circle, I am always hesitant to cross without seeing that the oncoming traffic is at a complete stop. Many times I have had to pull my children back or completely stop them, as drivers blow through. In addition, it is already incredibly difficult to turn off of Magnolia TC due the number of cars parked on the road. In order to see oncoming traffic, you basically have to drive right out into the street and hope for the best. As well, there is a school bus stop on the corner of Magnolia TC and Masters RD, in addition to a Calgary Transit stop. When these busses arrive to do pickup/drop off it IS impossible to turn onto/off of Magnolia Terrace as all traffic coming in either direction on Masters RD has to stop and wait for the bus to continue on. Adding a location that will most likely use the back lane for the daycare will only increase the degree of difficultly in getting off Magnolia TC at this spot.
2023/8/18 4:10 PM	This corner is far too busy for anything other than a residence. Cars constantly speed up to and around this intersection and traffic circle. There is no parking on the street in front of this lot, so pick up and drop off will either be people illegally parking IN the traffic circle, or in the alley behind blocking traffic or up the already busy Masters Rd. Little children are unpredictable and this is a dangerous location for when they escape a daycare or slip away from their parents. Mahogany is already saturated and the condos on Mahogany Blvd have exacerbated the situation. Combined with the lack of exits into 88th St or 196th Ave, this is going to create a huge flow issue

There will not be enough places to park and the congestion we see at the school parking lots in mahogany will happen at this traffic's circle as well.
