## **Public Member Appointments to the Council Compensation Review Committee**

#### **PURPOSE**

This Report presents applications from individuals seeking appointments as Public Members to the Council Compensation Review Committee. The Nominations Committee is asked to shortlist candidates and recommend Public Member appointments to Council, for its consideration at the 2024 January 30 Regular Meeting of Council.

- 1. Appoint Public Members to the Council Compensation Review Committee for terms set out in Confidential Attachment 2;
- Direct that Public Member appointments to the Council Compensation Review Committee be released publicly following appointee notification by the City Clerk's Office, no later than end of day Friday, 2024 February 2;
- 3. Authorize the destruction of all confidential ballots; and
- 4. Direct that Closed Meeting discussions and Confidential Attachments 2 and 3 remain confidential pursuant to Sections 17 (Disclosure harmful to personal privacy) and 19 (Confidential evaluations) of the *Freedom of Information and Protection of Privacy Act.*

### **HIGHLIGHTS**

- Council appoints and nominates Public Members to Boards, Commissions, and Committees ("BCCs") to provide skills, perspectives and expertise that contribute to good governance and strengthen relationships with Calgarians.
- Nominations Committee plays an important role in recommending candidates to Council for appointment to BCCs.
- The Council Compensation Review Committee was established by Bylaw 49M2023 at the 2023 October 24 Organizational Meeting of Council and therefore does not have a Chair to perform the screening and shortlisting process.

### DISCUSSION

There are five Public Member vacancies on the Council Compensation Review Committee for terms expiring on the date the Council Compensation Review Committee presents its final report to Council. The Nominations Committee is asked to review candidate applications (Confidential Attachment 3), short list candidates and recommend Public Member appointments to Council for its consideration at the 2024 January 30 Regular Meeting of Council.

As set out in section B.8(8) of Procedure Bylaw 35M2017, "Nominations Committee may sit in smaller panels to finalize interview questions and/or conduct interviews. The smaller panels may recommend nominations to Council."
