## ENMAX LEGACY PARKS PROGRAM – QUARTERLY UPDATE

### **EXECUTIVE SUMMARY**

In 2013 May, Council approved the Legacy Parks Fund Steering Committee Terms of Reference which proposed quarterly meetings, at the call of the Chair (Mayor). In 2014 September, the 2015 Legacy Park Fund Steering Committee (LPFSC) meeting dates were set for January 08, April 02, July 02 and October 22. The 2015 April 02 Legacy Park Fund Steering Committee meeting was cancelled; the report and attachments were distributed to committee members. This report provides a preliminary agenda for the 2015 October 22 meeting (Attachment 1), status updates for active Legacy projects from Phases 1, 2 and 3 (Attachment 2), and a financial update for all phases (Attachment 3).

There is a need to access Legacy Phase 3 Program funds as bridge financing for the Thomson Family Park project as summarized in Attachment 4. Final park design has been completed; the proposed bridge financing is required in order for the tender process to continue and for construction to begin on schedule in the fall of 2015.

### PREVIOUS COUNCIL DIRECTION / POLICY

On 2003 September 22, Council approved "The Legacy Parks Steering Committee mandate" as recommended in the Executive Report to Council, C2003-67 ENMAX Legacy Parks -Update.

At the 2012 November 20 meeting of the Legacy Parks Fund Steering Committee, the LPC2012-0808 Overview of Legacy Program – Legacy Parks Fund Steering Committee Terms of Reference was referred to Administration "to review the Legacy Parks Fund Steering Committee Terms of Reference, with a report back to Council no later than 2013 January".

On 2013 May 27 Council approved the Terms of Reference in LPC2013-0428 Proposed New ENMAX Legacy Parks Program Updates as outlined in corrected Attachment 1.

At the 2014 March 10 meeting of Council, LPC2014-0172 was approved as follows: Approve the proposed additional program criteria to include local community open spaces and approve proposed new projects as outlined in revised attachments.

At the 2014 November 03 and 04 meeting of Council, LPC2014-0823 Proposed Phase 3 ENMAX Legacy Parks Projects was approved.

## ENMAX LEGACY PARKS PROGRAM – QUARTERLY UPDATE

### **BACKGROUND**

Part of the ENMAX Legacy Parks Program funds the development of new regional parks in future growth corridors, including the land acquisition associated with the development of these parks. Previous major land acquisitions include: Ralph Klein Park, Haskayne Park, Bowmont East Gate (Klippert lands), as well as several smaller parcels in established communities. At the 2014 November 03 and 04 meeting of Council ENMAX Legacy Parks Phase 3 projects were approved; including upgrades to existing regional parks, development of new regional parks and improving existing community parks in underserviced areas of the city.

In 2014, Council approved new terms of reference that proposed quarterly meetings at the call of the chair (Mayor). At the 2015 January meeting of the Legacy Parks Fund Steering Committee meeting, the Committee requested that agendas come forward for future meetings as part of the quarterly LPC report. The 2015 April 02 meeting was cancelled, and the last meeting date for the year is 2015 October 22. The proposed agenda for the October meeting is included as Attachment 1. Updates on project status for all Legacy projects (Attachment 2) and a financial update to May 31, 2015 (Attachment 3) are provided as well.

A \$2 million dollar donation of private funds was pledged by the Thomson family for a park redevelopment project in the Beltline. The donation is coming to The City in annual instalments between 2014-2018. At the 2014 November 03 and 04 meeting of Council, \$2 million in Legacy Phase 3 funding was approved for Thomson Family Park. The Thomson Family Park redevelopment project has been through the public engagement, and the visioning and conceptual design phase, with the final concept design presented to the public at an open house in 2015 February. Detailed design, approvals and tender documents are now underway and targeted for completion in 2015 summer. Budget tied to the Thomson family donation cannot be requested until funds are received. In order for construction to proceed in 2015 fall, bridge financing is needed to cover project commitments until such time as the remaining Thomson family donation is received and budget can be requested. As the donations are received the borrowed funds will be repaid.

## **INVESTIGATION: ALTERNATIVES AND ANALYSIS**

A number of other ENMAX Legacy Parks Program projects approved in Phases 1, 2 and 3 of the program are underway or complete. Attachment 2 contains a status update on all ENMAX Legacy projects. Attachment 3 contains a financial update for all projects including actuals as of 2015 May 31.

In order for the construction of Thomson Family Park to remain on schedule, tender documentation needs to be approved and completed this summer. Administration reviewed other funding sources and determined that the timeliest option was to use Legacy Phase 3 funding to bridge finance the project in order to access the full donation today. The next opportunity to move funding forward at Council is 2015 September and this timing will cause project delays. Funding will be returned to Legacy Phase 3 as donation instalments are received from the Thomson family through to 2018. The proposed bridge financing is summarized in Attachment 4.

## Stakeholder Engagement, Research and Communication

The Thomson Family Park project has undergone extensive community and public engagement during the visioning and conceptual design phase completed in 2014. The final concept plan for the park was presented to the public in 2015 February and ongoing engagement with the Thomson family and key stakeholders have continued through the design development and detailed design phase.

# **Current and Future Capital Budget:**

\$2 million in existing Legacy Phase 3 appropriations (program 499, project 852) will be redirected to Thomson Family Park. Funds accessed will be replaced through a Thomson family donation spread between 2014-2018. Execution of other Legacy Phase 3 projects will not be impacted.
