- Why does it matter? The City Auditor's Office approved 2023 Audit Plan included a Downtown Calgary Development Incentive Program Audit to assess the effectiveness of the Program's incentive administration process. As of March 2023, \$130M has been allocated to 13 office-to-residential conversion projects. Given the significance of the investment, and high priority to Council, an effectively administered Incentive Program is vital to ensure fairness, enhance transparency, and mitigate associated reputational risks to The City and attract future Incentive Program applicants.
