Response to Motion Arising - Term Appointments for Members of Council to Boards, Commissions and Committees

#### **PURPOSE**

In preparing this Report and reviewing Governance Document(s) for BCC's to which Council appoints Members of Council, the City Clerk's Office was unable to identify any references to rationale for the length of appointment terms.
