## **BYLAW NUMBER 12M2024**

BEING A BYLAW OF THE CITY OF CALGARY
TO AMEND BYLAW 35M2017,
THE PROCEDURE BYLAW
AND BYLAW 26M2018,
THE CODE OF CONDUCT FOR ELECTED
OFFICIALS BYLAW

**WHEREAS** Council has considered EC2024-0181 and considers it desirable to amend Bylaw 35M2017, the Procedure Bylaw and Bylaw 26M2018, the Code of Conduct for Elected Officials Bylaw;

## NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. Bylaw 35M2017, the Procedure Bylaw, as amended, is hereby further amended as follows:
  - (a) Section 29.1 is deleted and replaced with the following:
    - "29.1 A *Member* may on occasion participate in *Council* or *Council Committee* meetings remotely, in accordance with the procedures set out in Appendix F.";

and

## (b) in **APPENDIX F – REMOTE PARTICIPATION AT MEETINGS**:

- (i) section F.1 is deleted and replaced with the following:
  - "F.1 (a) A Member may on occasion *participate remotely* in a *Council* or *Council Committee* meeting provided they are in an appropriate and secure location free from distractions with their camera on and no background used.
    - (b) Best efforts must be used to attend Council or Council Committee meetings, including Closed Meetings, in person conforming with the Code of Conduct for Elected Officials Bylaw (26M2018). Compliance is overseen by the Integrity and Ethics Office.";

and

- (ii) section F.8 is deleted and replaced with the following:
  - "F.8 Remote participation is permitted in Closed Meetings provided a Member is in a private and secure location free from distractions with their camera on and no background used."
