Public Member Resignations and Appointments to Boards, Commissions and Committees

#### **PURPOSE**

The purpose of this report is:

- To recommend that Council fill vacancies created by mid-term resignations on Boards, Commissions and Committees ("BCCs") from Reserve Lists;
- To present the person appointed by the Executive Officer of HMCS Calgary to the Friends of HMCS Calgary Subcommittee of the Calgary Salutes Committee;
- To appoint two Public Member nominees and one Administration member to fill Public Member vacancies from the 2023 October 24 Organizational Meeting of Council; and
- To present an amendment to the Calgary Salutes Committee Bylaw 36M2023 to clarify the composition of the subcommittees.

### PREVIOUS COUNCIL DIRECTION

Section 5.18.3 of Council Policy CP2016-03, *Governance and Appointments of Boards, Commissions and Committees* ("the Policy") provides that, upon notification of a vacancy on a BCC, the City Clerk's Office contacts Reserve List applicants to determine if they are still interested and available to serve as a Public Member. The City Clerk's Office contacted the Reserve List applicants to confirm their continued interest and availability: only those who expressed an interest in serving are presented with this report. The resulting Reserve List is submitted to Council and may be used to fill the vacancy.

- 8. Appoint the Administration member named in Confidential Attachment 6 to the BiodiverCity Advisory Committee for a two-year term expiring at the 2025 Organizational Meeting of Council;
- 9. Give three readings to proposed Bylaw 11M2024, to amend the Calgary Salutes Committee Bylaw 36M2023 (Attachment 7);
- 10. Direct the City Clerk to make the appointments publicly available following notification of the appointees and their acceptance of appointments; and

### Mid-Term Resignations:

The City Clerk's Office was notified of the following Public Member resignations:

- Matthew Corkum resigned from the Advisory Committee on Accessibility;
- Yee Nap (Joshua) Chan resigned from the Anti-Racism Action Committee;
- Kelvin Whalen resigned from the Assessment Review Board:
- Harris Switzman resigned from the Climate Advisory Committee;
- Eppo van Weelderen resigned from the Education and Training Subcommittee of the Calgary Salutes Committee; and
- Lieutenant(N) Riley Perrior resigned from the Friends of HMCS Calgary Subcommittee of the Calgary Salutes Committee.

Four BCCs indicated that vacancies should be filled from the Reserve List candidates. The Education and Training Subcommittee of the Calgary Salutes Committee indicated that the position should remain vacant until the 2024 Organizational Meeting of Council.

Subcommittee. The Executive Officer has appointed Lieutenant Commander Malorie Aubrey to this position.

## **Outstanding Appointments:**

The Social Wellbeing Advisory Committee's composition includes representatives of the Advisory Committee on Accessibility and the Calgary Aboriginal Urban Affairs Committee. At the 2023 October 24 Organizational Meeting of Council, the Advisory Committee on Accessibility and the Calgary Aboriginal Urban Affairs Committee requested to submit their nominations once their membership was complete. The nominees of the Advisory Committee on Accessibility and the Calgary Aboriginal Urban Affairs Committee are presented in Confidential Attachment 5.

The BiodiverCity Advisory Committee's composition includes Administration members. At the 2023 October 24 Organizational Meeting of Council, a position was left vacant. To fill this vacancy, the Chief Administrative Officer is recommending appointment of an Infrastructure Services Department employee whose name is presented in Confidential Attachment 6.

## Amendment to the Calgary Salutes Committee Bylaw 36M2023:

The Calgary Salutes Committee Bylaw 36M2023 currently states that the three subcommittees - Education and Training Subcommittee, Friends of HMCS Calgary Subcommittee, Heritage and History Subcommittee – are composed of nine members. Proposed Bylaw 11M2024 brings clarity to the composition by allowing the subcommittees to be comprised of up to nine members, and no less than six (Attachment 7).
