#### HIGHLIGHTS

- This application proposes new street names Saddlehorse, Saddleacre, Saddlehaven, Saddleranch.
- Administration recommends approval of the proposal as it complies with the Municipal Naming, Sponsorship and Naming Rights Policy.
- What does this mean to Calgarians? Municipal naming of roadways plays an important role in simple and unambiguous identification for location and navigation within Calgary.
- Why does this matter? The proposal will assist citizens and emergency services operators with navigation to and within the developing community of Saddleridge by allowing for unique street names in the community.
- The application is associated with a land use and outline plan application, LOC2017-0382.
- There is no previous Council direction regarding this proposal.

# **DISCUSSION**

This application in the northeast community of Saddleridge was submitted by B&A Studios, on behalf of the landowners (Attachment 1), on 2022 April 28. The subject land is located north of 80 Avenue NW, east of Métis Trail NE, south of 84 Avenue NE, and west of 52 Street NE. Location Maps are provided in Attachment 2.

The street names application is associated with land use and outline plan application, LOC2017-0382 (Attachment 3).

As indicated in the Applicant Submission (Attachment 4), the proposed street names are intended to honor Alberta's horse breeding culture, as well as the homesteaders, farmers and acreage owners who have existed in Saddle Ridge for many decades, while also reinforcing that the subject neighbourhood is in the community of Saddle Ridge.
