AUTHORIZATION FROM COUNCIL TO COVER EXPENSES OF PROSPECTIVE FEDERATION OF CANADIAN MUNICIPALITIES DIRECTORS

EXECUTIVE SUMMARY

To provide authorization to cover the expenses of the prospective Federation of Canadian Municipalities (FCM) Director.

CITY CLERK'S RECOMMENDATION

That Council agrees that should The City of Calgary's Nominee to FCM be elected to the FCM Board of Directors, Council is prepared to meet all reasonable costs of attendance at meetings of the FCM Board of Directors; such costs to be charged to Corporate Costs.

PREVIOUS COUNCIL DIRECTION / POLICY

At the 2002 October 21 Organizational Meeting of Council, the following resolution was adopted:

"That the Council of The City of Calgary hereby agrees that should its representatives to FCM be elected to the FCM Board of Directors, that Council is prepared to meet all reasonable costs of attendance at meetings of the FCM National Board of Directors; such costs to be charged to the Corporate Costs."

This resolution is documented in the Council policy on *Council to Cover Expenses of Prospective FCM (Federation of Canadian Municipalities) Directors* (CC008).

BACKGROUND

The FCM Board of Directors manages or supervises the management of the activities and affairs of the Federation. In accordance with section 3.04(i) of the FCM Bylaw No. 1, there shall be seven Directors representing Alberta, consisting of one nominee selected by The City of Calgary. Only elected municipal officials are eligible to be Directors.

INVESTIGATION: ALTERNATIVES AND ANALYSIS

Council selects a nominee to FCM annually at the Organizational Meeting of Council. FCM requires a resolution from Council each year confirming that costs of attendance at meetings of the FCM Board of Directors will be covered by The City of Calgary.

Stakeholder Engagement, Research and Communication

In preparation of this report, the City Clerk's Office reviewed the Council policy on *Council to Cover Expenses of Prospective FCM (Federation of Canadian Municipalities) Directors* (CC008) and Bylaw No. 1 of the FCM (Adopted 2016 June 05).
