#### **BYLAW NUMBER 18M2024**

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 20M88, THE STREET BYLAW

**WHEREAS** Council has considered IP2024-0103 and considers it necessary to amend the Street Bylaw 20M88;

## NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. Bylaw 20M88, the Street Bylaw, as amended, is hereby further amended.
- 2. Section 2 is amended by adding the following after subsection (17.4) as subsection (17.4.1):
  - "(17.4.1) "Protected Bicycle Lane" means an exclusive bicycle lane designated by the Traffic Engineer under Bylaw 26M96, the Calgary Traffic Bylaw, that is separated from other parts of a Roadway by a physical barrier;".
- 3. Section 67(7) is deleted and the following is substituted:
  - "(7) An owner or occupant of a parcel of land must not remove snow or ice from the parcel and place it anywhere on a:
    - (a) Roadway, including a Protected Bicycle Lane; or
    - (b) Boulevard.
  - (8) An owner or occupant of a parcel of land must not remove ice and snow from the Sidewalk or Pathway adjacent to the parcel and place it on a Protected Bicycle Lane but may do so on other portions of the Roadway or Boulevard.
- 4. Section 88 is amended as follows:
  - (a) In subsection (8), after the words "section 67(1)", the following is added:
    - ", 67(7) or 67(8)".
  - (b) In subsection (9), after the words "section 67(1)", the following is added:
    - ", 67(7) or 67(8)".
- 5. Schedule "E" is deleted in its entirety and the following is substituted:

67 (1)	Owner or occupant fail to remove ice and snow from adjacent Sidewalk or Pathway within 24 hours	\$150	\$250
67 (7)	Remove snow or ice from parcel and place it on Roadway, Boulevard, or a Protected Bicycle Lane	\$150	\$250
67 (8)	Remove snow or ice from Sidewalk or Pathway and place on Protected Bicycle Lane	\$150	\$250".
