## REFERRED REPORT

POLICY AMENDMENT AND LAND USE AMENDMENT, RAMSAY (WARD 9), 11 STREET SE, SOUTHWEST OF CPR LINE,

BYLAWS 32P2015 AND 149D2015, (CPC2015-154), C2015-0938

Background: At the 2015 December 07 and 08 Combined Meeting, City Council referred

Report C2015-0938 to the 2016 January 11 Combined Meeting of Council in order to re-advertise proposed Bylaw 149D2015 for an amendment to density. The amendment requires a new Public Hearing to be held on the amendment to change the land use district to M-H2. Following the Public Hearing, if the change to land use district M-H2 is desired. Council must

adopt the amendment prior to second and third Readings.

Ineligible to Vote: A Public Hearing with respect to Bylaws 32P2015 and 149D2015 was held on

2015 September 14. All Members of Council were in attendance and are

eligible to vote.

- 3. Give second and third readings to Bylaw 149D2015, as amended; and
- 4. Give second and third readings to Bylaw 32P2015.
