
## **BYLAW NUMBER 121D2015**


**WHEREAS** it is desirable to amend the Land Use Bylaw Number 1P2007 to change the land use designation of certain lands within the City of Calgary;

#### DC DIRECT CONTROL DISTRICT

## **Purpose**

This Direct Control District is intended to provide for medium rise **Multi-Residential Development** in a variety of forms and densities with the option of **commercial multi-residential uses** within a residential **building**.

### Compliance with Bylaw 1P2007

2 Unless otherwise specified, the rules and provisions of Parts 1, 2, 3 and 4 of Bylaw 1P2007 apply to this Direct Control District.

## Reference to Bylaw 1P2007

Within the Direct Control District, a reference to a section of Bylaw 12007 is deemed to be a reference to the section as amended from time to time.

#### **Permitted Uses**

The **permitted uses** of the Multi-Residential – High Density Medium Rise (M-H2) District of Bylaw 1P2007 are the **permitted uses** in this Direct Control District.

## **Discretionary Uses**

The **discretionary uses** of the Multi-Residential – High Density Medium Rise (M-H2) District of Bylaw 1P2007 are the **discretionary uses** in this District Control District.

#### **Bylaw 1P2007 District Rules**

6 Unless otherwise specified, the rules of the Multi-Residential – High Density Medium Rise (M-H2) District of Bylaw 1P2007 apply in this Direct Control District.

### Floor Area Ratio

7 There is no minimum or maximum floor area ratio in this Direct Control District.

## Density

The minimum **density** in this Direct Control District is 50 units per hectare.

## **Building Height**

9 (1) A maximum of two **buildings** within this Direct Control District may have a maximum **building height** of 50.0 metres.

(2) In all other cases, the maximum building height is 21.0 metres.

#### Relaxations

The **Development Authority** may relax any of the rules contained in this Direct Control District in accordance with Sections 31 and Section 36 of Bylaw 1P2007.
