BYLAW NUMBER 31M2015

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 6M2007, THE LIVERY TRANSPORT BYLAW

WHEREAS Council has considered CPS2015-0580 and deems it necessary to amend Bylaw 6M2007, the Livery Transport Bylaw;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. Bylaw 6M2007, the Livery Transport Bylaw, as amended, is hereby further amended,
- 2. (1) In Bylaw 6M2007, the word "**Manager**" is deleted and replaced with "**Chief** Livery Inspector" wherever it appears.
 - (2) The heading "PART 3 MANAGER" is deleted and replaced with "PART 3 CHIEF LIVERY INSPECTOR".
- 3. Section 6 is deleted and replaced with the following
 - "6. (1) Nothing in this Bylaw relieves a **Person** from complying with any Federal or Provincial law or regulation, other bylaw or any requirement of any lawful permit, order or licence.
 - (2) Specific references to laws in this Bylaw are meant to refer to the current laws applicable within the Province of Alberta as at the time this Bylaw was enacted and as they are amended from time to time, including successor legislation."
- 4. In section 12:

"(a

(a) subsection 12(a) is deleted and replaced with the following:

"Accessible Taxi" means a Motor Vehicle which has an A.T.P.L. joined to it;"

(b) subsection 12(f) is deleted and replaced with the following:

"(f) "A.T.P.L." or "Accessible Taxi Plate Licence" means a Licence Issued pursuant to section 90 and includes a A.T.P.L.-1 and a A.T.P.L.-2;";

- (c) subsection 12(h) is deleted and replaced with the following:
 - "(h) "Brokerage" means a Person who holds a Licence Issued by the Chief Livery Inspector to conduct Brokerage Operations;";
- (d) the following is added after subsection 12(I) as subsection 12(I.1):

- "(I.1) "**Chief Livery Inspector**" means the chief administrative officer of the City of Calgary or his or her designate;";
- (e) subsection 12(q)(ii) is deleted;
- (f) subsection 12(w) is deleted and replaced with the following:
 - "(w) "Licence" means a licence issued under this Bylaw;";
- (g) in subsection 12(x), the words "Bylaw 48M2007" are deleted and replaced with "Bylaw 50M2011";
- (h) subsection 12(bb) is deleted and replaced with the following:
 - "(bb) "L.P.L." means a Licence Issued by the Chief Livery Inspector which permits a Motor Vehicle to be Operated as a lineousine;";
- (i) subsection 12(ee) is deleted and replaced with the following.
 - "(ee) "Livery Vehicle Registration Certificate" means a Certificate which indicates that the Motor Vehicle in respect of which it is Issued is qualified to have a Plate joined to it;":
- (j) subsection 12(gg) is deleted;

- (k) subsection 12(ii) is deleted and replaced with the following:
 - "(ii) "**Motor Vehicle**" means a motor vehicle as defined in the <u>Traffic Safety</u> <u>Act</u>, R.S.A. 2000, c. 7-6,":
- (I) subsection $12(n_0)$ is deleted and replaced with the following:

"(nn) "Plate" means a T.P.L., A.T.P.L. or L.P.L.;";

 (n_1) subsection 12(tt) is deleted and replaced with the following:

"T.P.L." or **"Taxi Plate Licence**" means a **Licence Issued** pursuant to section 89.01 and includes a T.P.L.-1 and a T.P.L.-2;".

- 5. Subsection 22(b)(v) is deleted and replaced with the following:
 - "(v) transportation of passengers with disabilities;"
- 6. In section 25, the words "with the current City of Calgary validation tab attached" are deleted.

- 7. The following is added after section 36 as sections 36.1 and 36.2:
 - "36.1 No **Person** shall **Operate** a **Taxi** or **Accessible Taxi** with the **Taximeter** turned on unless the **Taxi** or **Accessible Taxi** is engaged by a customer.
 - 36.2 No **Person** shall fail to pay any fare or fee lawfully required for the **Person's** hire of a **Taxi**, **Accessible Taxi**, or **Limousine**."
- 8. In section 39.1:
 - (a) subsection 39.1(1)(a)(ii) is deleted and replaced with the following:
 - "(ii) that is mounted on the inside of the windshield, or in another suitable position, facing rearward and that is continually recording audio and video of all occupants in the **Taxi** or **Accessible Taxi** at all hours of the day or night; and";

and

- (b) the following is added after subsection 39.1(3) as subsection 39.1(4):
 - "(4) A Person must not:-
 - (a) tamper or interfere with a security camera; or
 - (b) block, obstruct or disable a security camera so that it cannot capture audio and video of all occupants in the **Taxi** or **Accessible Taxi**."
- 9. In section 59, the words "on his person" are deleted and replaced with "in his or her possession".
- 10. Section 65 is deleted and replaced with the following:

65. No **Person** shall offer for hire a **Motor Vehicle** in the **City** which has markings, decals, or equipment identifying it as a taxi, accessible taxi or limousine unless that **Motor Vehicle** has a valid **Livery Vehicle Registration Certificate**."

- 11. In section 86:
 - (a) section 86(e) is deleted and replaced with the following:
 - "(e) must keep a log book in English in a form and manner approved by the **Chief Livery Inspector;**
 - (e.1) must retain the log book for a minimum of one year following the date of the last entry;

- (e.2) must enter the following information for each shift by the end of the **Driver's** shift each day:
 - (i) the date and time the **Driver** starts **Operating** the **Livery Vehicle**;
 - (ii) the time and date when every passenger is picked up;
 - (iii) the location at which every passenger is picked up;
 - (iv) the destination at which every passenger is discharged; and
 - (v) the time the **Driver's** shift ends;";

and

- (b) in section 86(f), the words "on his person" are deleted and replaced with "in his or her possession during the **Driver's** shift".
- 12. Subsection 95(1) is deleted.
- 13. The following is added after section 128 as section 128.1:
 - "128.1 If the **Chief Livery Inspector** determines that a **Brokerage** is not in compliance with any provision of this Bylaw, the **Chief Livery Inspector** may prohibit any **Plate** from continuing to affiliate, or becoming affiliated, with that **Brokerage** until such time as the **Brokerage** has remedied the non-compliance."
- 14. In section 165(1), the words "Bylaw 48M2007" are deleted and replaced with "Bylaw 50M2011".
